REQUEST DESCRIPTION

1. Activity: Please describe your proposed activity in detail

Leadership Development and support for Local Leaders

NPOC managed initiative to identify and mentor selected noncommercial leaders from four regions over the next fiscal year, to develop a group of participants both within NPOC and the NCSG, but also to support the Outreach Initiative activities. Our goal is to bring acknowledged non commercial leaders as participants from a range of countries to ICANN meetings, with an objective of 2 per meeting A & C and 2 leaders to Internet Governance (IG) meetings (e.g. IGF and CSTD/WSIS) as part of noncommercial engagement in support of ICANN strategic objectives 1 (Evolve and further globalize ICANN) & 4 (Promote ICANN's role and multistakeholder approach). Participants will be selected based on criteria of NPOC ExCom that there is a potential, or very new member with presence in that country via a noncommercial organization who can participate and a willingness to work as part of this project.

Participants would participate in ICANN's meetings and orientations, including potentially joining some of the ICANN Fellowship activities if suitable, but would be primarily focused on participation with NPOC and relevant workshops and topics that support the Local Leader's ability to complete a small project back in their country. Ideally, each local leader would have funding to attend two ICANN meetings and an IGF & WSIS/CSTD meeting, where their focus would be around the CIR and related activities (with speaking roles) which are of relevance to noncommercial concerns of impact to ICANN's larger role and activities.

In particular, representatives from organizations who can easily conduct an event for noncommercials' in their locale, or in conjunction with another conference or activity that they are already engaged in will be prioritized. This is a leader's program, so priority will be given to mature and capable participants, rather than young managers, although this group is also important in the longer run.
