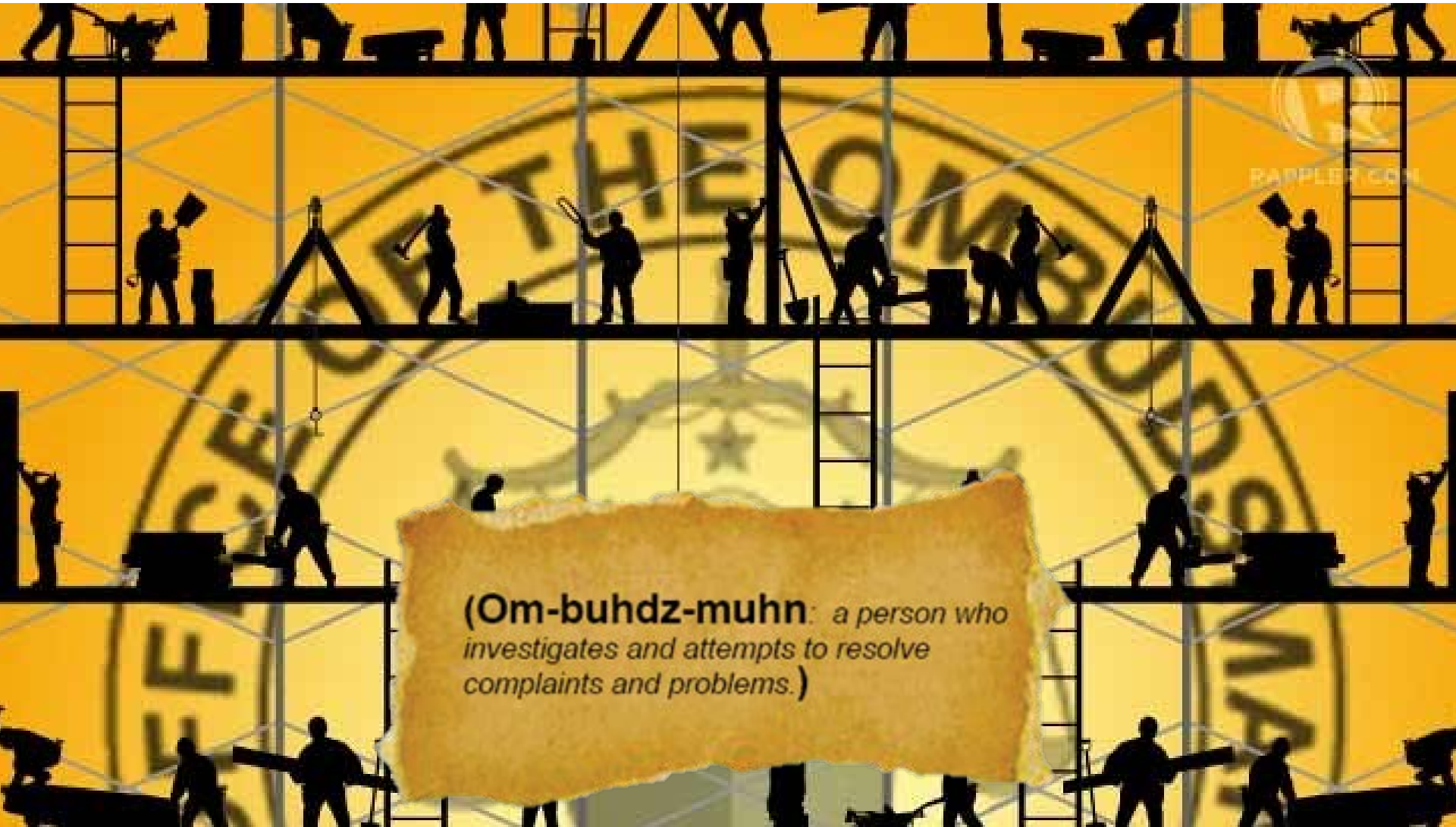

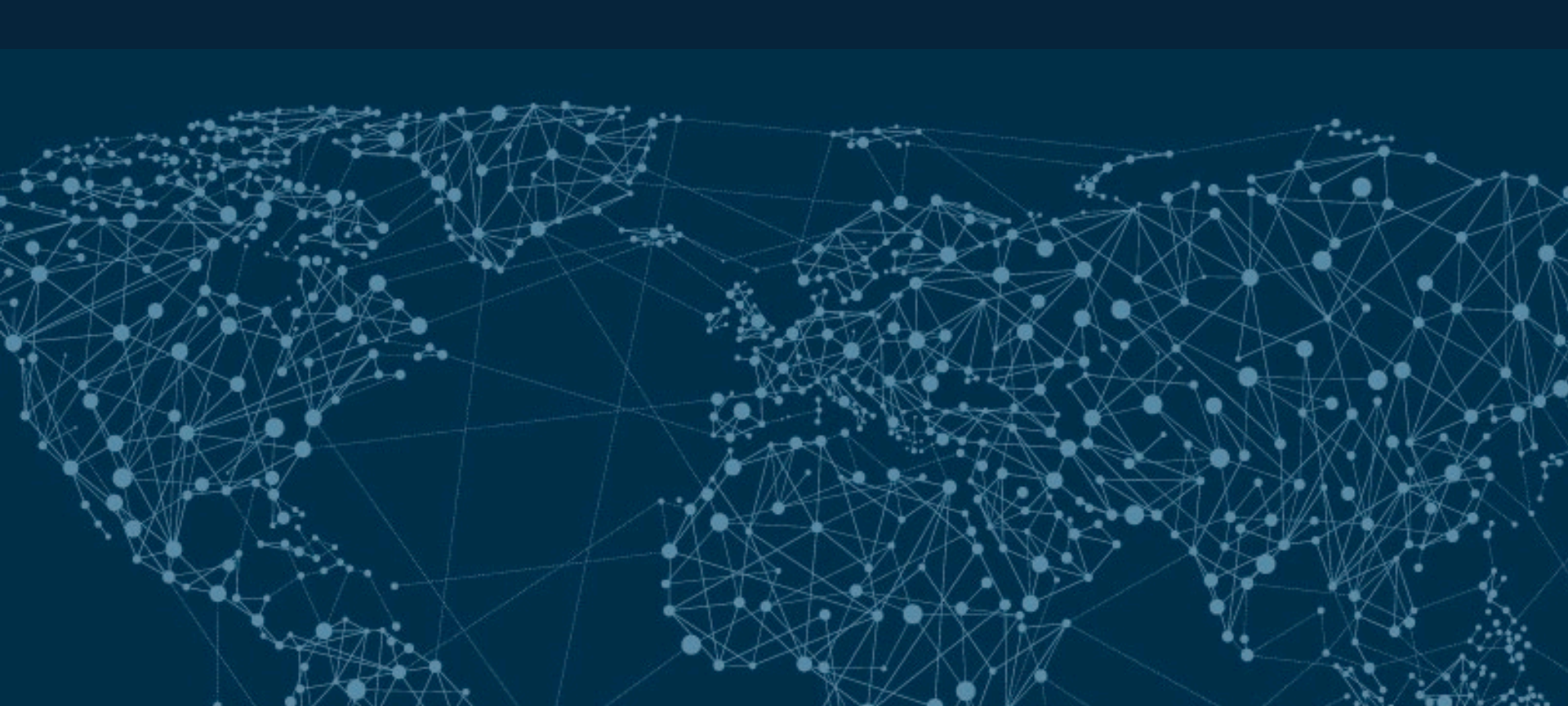

ICANN Ombudsman Assessment

6 March 2017

- ⦿ Bids assessed independently by multiple members of ICANN organization
- ⦿ Interviews conducted with three bidders that received the highest combined scores
- ⦿ Checked references for top two bidders following interviews
- ⦿ Decision between the last two candidates was based on experience of Ombudsman reviews vs knowledge of ICANN

Evaluation Criteria

- Overall Criteria categories:
 - Flexibility
 - Financial Value
 - Proposed Methodology
 - Understanding of the Assignment
 - Knowledge and Expertise
- Each category had between one (financial value) and twelve (knowledge and expertise) different sub-categories, such as:
 - “Demonstrated understanding of non-for-profit or non-governmental organizations “
 - “Suitability for engagement volunteers within volunteer-based organization”
 - ”Knowledge of the Ombudsman Office”
- If bid falls inside the allocated budget, it receives the highest ‘financial value’ mark.

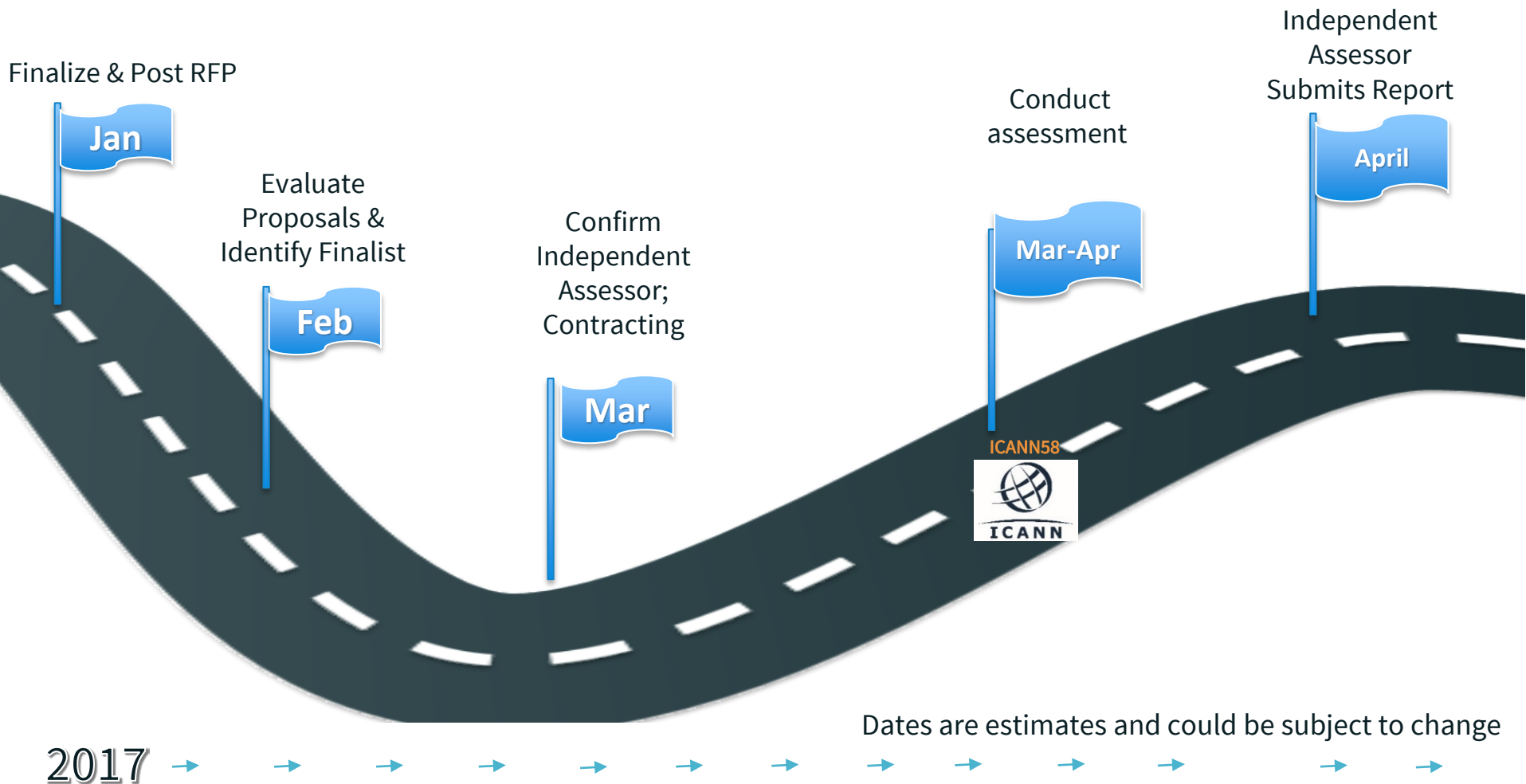
Next Steps
