Greg Shatan: That said there has been some inequitable pricing aimed at getting higher prices for defensive registrations.

Vanda: Greg. defensive registration I beleive will increase qith the initial price reduced. more people can register a brand name if the cost is reduced.

Alexander Schubert 2:Can't hear Kavouss speaking. I am on Adobe only. Can it be that the phone lines aren't looped into the Adobe Audio?

Vanda:so the need of defensive registration will grow Vanda:Alex, I am only at adobe and hear him quite well

Anne Aikman-Scalese (IPC: 1.1(c) in the ByLaws carves out measures that are consistent with the Mission . For example, 1.1(c) apparently does not prohibit GAC Safeguards to certain strings.

Kristina Rosette (Amazon Registry):I like the idea of identifying the comment requests, stating them at the beginning, and identifying the recommendations to which they apply. The recommendation-specific requests would then be only that - recommendation-specific.

Steve Chan: I think Kavouss' point is at least in part, taken into account in the third paragraph of the high-level feedback?

Alexander Schubert 2:Vanda: I think for th majority of run of the mill gTLDs defensive and speculative registrations are the main revenue stream. Sadly.

Vanda: you right, but is not reducing price that this will change

Greg Shatan: Vanda, you may be right when it comes to "penny pricing.". But I don.t think using price as a barrier to abusive registrations is the solution, since the practical effect (and possibly the intent) is to milk brand owners like cash cows.

Greg Shatan:Alexander, you may be right. Which would be quite sad. Either way those sales are to registrants with little or no intent to use the domains for websites, emails, etc. At that point it's just speculators and suckers....

avri doria:Kavouss understood you thought a group parralell to the gTLD-IRT could do it. That is possible but someone else would have to charter it.

Paul McGrady:a predictable process with knowable deadlines and subject matter guidelines

Kavouss Arasteh:PICs may normally be changed
