



(2) In our current RDS, this data is made available both by registrars and (thick) registries. They sometimes differ. Only one can be authoritative. But the system provides both. 2	I'm not comfortable with including "authoritative" unless we have a corresponding definition of the word. My concern is based on a belief that people may associate possession with authority and I do not believe that association is always correct.	3/8/2017 7:03 PM
3	My definition of "authoritative" is "the data that's in the registry." That's the standard industry and the historical understanding. It means that contact data in the registry (and thus the RDS) can be inaccurate, but it's what's on the record. "Facilitate dissemination" is a poor substitute that doesn't add anything and may even be inaccurate. "Facilitate" means "to make (an action or process) easy or easier." But either RDS provides registration data or it does not, and a basic purpose of RDS is certainly o provide registration data. "Facilitate dissemination" is more about the HOW or TO WHOM, and those issues are covered under "applicable policy."	3/8/2017 5:16 PM
