- Assumptions 1 hour call can start between 0600 and 2200 local time 5 days per week - try to avoid Mondays and Fridays for date changes
- Assumptions 0500, 1300 and 1900 times are reserved for WS2 slots
- Assumption CCT meets Wednesday or Thursdays at 1500 every week for a 2 hour call
- Recommendation 1400UTC Tuesdays
- Need to determine frequency – every week or every other week and on a specific day of the week
