

Terms and Conditions

1. INTRODUCTION

These Terms and Conditions shall govern ICANN's Capacity Building Prize draw entitled "Getting LACRALO involved" which is organized by ICANN's LAC GSE and LACRALO leadership for the LACRALO community members.

LAC GSE and LACRALO leadership is organizing a series of five (5) Capacity Building Webinars in 2017 for the LACRALO Community; the objective is to provide information from experts about PDPs topics and active processes taking place at ICANN.

The five (05) capacity building webinars in 2017 will take place after some LACRALO monthly calls determined beforehand.

The prize will come out off the budget of another LAC Strategy Project entitled "Contest and Awards" with the objective on incentivizing LACRALO's overall participation.

2. DRAW MECHANISM OF THE PRIZE

In December 2017, a random draw will take place to determine one (01) winner among all the LACRALO community members who participated in 4 of the five (5) Capacity Building webinars.

3. ELIGIBILITY

Capacity Building Prize draw is open to all LACRALO community members.

LACRALO community members must be citizens of Latin America or Caribbean Islands countries and must be over 18 years old or above at the time of the draw. Proven citizenship is required.

To be eligible to participate in the prize draw, all participants must have attended 4 of the following webinars:

Empowered Community
Review of All Rights Protection Mechanisms in All gTLDs PDP
Country and Territory Names as TLDs
Access to Curative Rights Protections of the UDRP/URS for IGOs/INGOs PDP
Purpose of gTLD Registry Data PDP

4. DRAW DATE

ICANN's Capacity Building Prize draw will take place 21 December 2017.

5. WINNER

A winner will be selected from a random draw among all LACRALO Community members that participated in 4 out of the 5 LACRALO Capacity Building webinars in 2017.

6. PRIZE

A round trip to ICANN's Los Angeles Office from the country of origin that must be located in the Latin America or Caribbean Islands.

Coach class airfare (dates to be determined by ICANN, but flexible as reasonably necessary to accommodate Winners schedule), hotel accommodation for 6 days and 5 nights standard to be arranged by ICANN and a per diem of 30\$. All other costs and expenses are the responsibility of the winner.

Training at ICANN's Los Angeles office will be scheduled during the winners stay to learn in depth about ICANN, structure, services, policymaking and

more. Winner must commit to present a resume of activities and share the experience in a LACRALO monthly call in the dates duly coordinated with the LACRALO Leadership.

The winner is responsible for complying with any visa requirements to enter the United States.

7. LEGAL TERMS

The winner must sign a release to claim the prize and to agree to allow ICANN and LACRALO to use their name, image and/or likeness for promotional purposes and/or in social media without further compensation, fee, royalty and/or validation.

Winner may not request substitution or other consideration of the prize specified and the prize is non-transferable and has no cash value, expressed or implied.
