Maxim Alzoba (FAITID):Hi ALI

Amr Elsadr:Hi Maxim.

Mary Wong:Good idea, Lori!

Maxim Alzoba (FAITID):could we resize windows - so the shared one is bigger (by making notes bit smaller)?

Maxim Alzoba (FAITID):that is why I drag with me 2 LTE phones + one modem from 2 providers :)

Maxim Alzoba (FAITID):and another ISP at home

Mary Wong:Hmm I'm not sure it makes much difference, Maxim - maybe Terri or Julie can confirm (or better yet, help!)

Maxim Alzoba (FAITID):it is enough, on the second thought

Jeff Neuman:I am in listen only mode for today

Mary Wong:Me too, mostly - this seems to be the noisiest airport lounge ever (Newark). Sorry.

Maxim Alzoba (FAITID):please post the URL to Google doc to the chat

Mary Wong:@Lori, that was going to be the staff suggestion as well.

Terri Agnew:@Maxim, pod have been adjusted slightly, I don't think it helped much

Maxim Alzoba (FAITID):also there were some comments made by me, which are not visible on the shared PDF

Mary Wong:That was in case there are further updates from today.

Terri Agnew:Sync is on, everyone can adjust size of screen themselves

Mary Wong:So basically the final document will have the original Charter question (not in this document, sorry), and whatever final updated version is proposed by the Sub Team (right most column)

Griffin Barnett:same here

Amr Elsadr:And distorted.

Matt Mlsna:same here

Terri Agnew:@Kristine, your audio is not clear, please let me know if a dial out on the telephone is needed

Maxim Alzoba (FAITID):too close to mic

Kristine Dorrain - Amazon Registry Services:BRB

Philip Corwin:Kristine's audio is unintelligible

Mary Wong:@Lori, when circulating the links to the materials along with the question, the Sub Team can also ask if Working Group members think there needs to be further discussion after they have reviewed the materials. We can also suggest to other Sub Teams that any time a team feels an "informational/educational" type question is included, a similar approach be proposed.

Kristine Dorrain - Amazon Registry Services:I'm back...if I can get back in the queue

Maxim Alzoba (FAITID):I have a question about 2. comment - I think we mix premium names and reserved names - I do not think it is right

Amr Elsadr:Much better Kristine.

Mary Wong:@Maxim, that's why there was an earlier suggestion that we've carried over, as to whether definitions are needed. Most people felt it would be helpful, I believe.

Maxim Alzoba (FAITID):definitions are good idea

Mary Wong:Deloitte also provided that information in writing, in their initial response to the data gathering questions.

Kristine Dorrain - Amazon Registry Services:Even better, Mary! I definitely remember the verbal presentation.

Amr Elsadr:@Maxim: regarding question 2, this comment is in the google doc, but couldn't be exported into the pdf version. Apologies.

Maxim Alzoba (FAITID):shall I add it to the text?

Mary Wong:@Lori, shall we make it an action item to discuss possible definitions for premium names, reserved names and premium Sunrise pricing on the list?

Mary Wong:@Lori (sorry) - yes to the time estimation. I think we'd gotten to 3.5 - 4 calls for the first few questions. I will check exactly where we stopped.

Maxim Alzoba (FAITID):ok - I will move it from the comments to the text

Amr Elsadr:Thanks.

Maxim Alzoba (FAITID):about publishing of reserved names - I'd like to try to speak

Jeff Neuman:I would change "words" to "strings" since that would be more accurate

Lori Schulman:good suggestion Jeff -- strings

Mary Wong:@Lori I've pasted the data discussion and timeline estimates from last week to the Agenda pod on the right.

Kristine Dorrain - Amazon Registry Services:To be clear, I don't believe Maxim claimed to speak for the registries as a whole. :)

Kristine Dorrain - Amazon Registry Services:+1 Kathy

Mary Wong:J. Scott had suggested that any questions that need data gathering be dealt with last in order by the WG, to allow for the data to be obtained

Jeff Neuman:This issue will take a while

Jeff Neuman:Lots of complexities

Mary Wong:@Lori, all, see the time estimates from last week on the right (Agenda pod)

Jeff Neuman:Where to publish, how often, etc.

Maxim Alzoba (FAITID):it may vary from country to country ...

Jeff Neuman:The list of stings changes when any changes are made in the TMCH

Maxim Alzoba (FAITID):in our case it is 9k lines of really bad language ...

Mary Wong:Note that we've not had good luck with registry responses to date

Mary Wong:And no luck at all with registrars.

Kristine Dorrain - Amazon Registry Services:Fair point, Mary, but this one might get some attention

Mary Wong:Yup, not disagreeing, Kristine, just noting for realistic expectations :)

Maxim Alzoba (FAITID):though - providing ICANN with reserved lists on requests of the group looks fine on terms of non-disclosure of the lists

Jeff Neuman:I think more calls

Jeff Neuman:Lots of complexities

Maxim Alzoba (FAITID):so tests on examples could be ran, but nothing more

Jeff Neuman:I am multi-tasking so cant talk

Kristine Dorrain - Amazon Registry Services:Reserved names MAY be released at some point.

Philip Corwin:Exactly. Reserved names for this exercise are those not available for sunrise registration but that may be released subsequent to it (or may never be released).

Mary Wong:All, just a head's up that since some of the original questions have been rephrased and/or combined, staff will go back to check that the timeline estimates and data discussion from last week match up (or are updated following today, as the case may be).

Maxim Alzoba (FAITID):for example- single letters - they are limited to 26 ascii and there is a reason for having them in premium

Maxim Alzoba (FAITID):\*in premium pool

Maxim Alzoba (FAITID):and example for unavailability of POLICE in GEOs - for example is that local police have right to use it

Mary Wong:@Phil, that sounds useful - the Sub Team will probably need to discuss what data points can be used for the sampling, though.

Philip Corwin:@maxim--would agree that single letter domains would likely be on any registry's premium list, and hard to fault

Maxim Alzoba (FAITID):the same with 2 letters

Maxim Alzoba (FAITID):at least those available

Amr Elsadr:@Maxim: Could you clarify if you believe the question shouldn't be asked, or if you were trying to answer the question by saying "no"?

Mary Wong:@Lori, on the scope/reason for this question - from the public comments received it's more likely that Sunrise can be the mechanism, but may not be the only or preferred one.

Kathy Kleiman:Data gathering: what type of overhead, cost and management would then be required?

Maxim Alzoba (FAITID):The reason is poor design of ALP - GEOs could not use it ... only one tried and still not launched

Philip Corwin:Should there be a sunrise registration period for any domain released from a registry's reserved list? -something like that for rephrasing

Maxim Alzoba (FAITID):and the reserved lists is the only way to deliver names to city - POLICE should go to Public Authority and not to Eyewear maker

Mary Wong:Sunrise was suggested, but I believe the commenters were open to other mechanisms if they exist or can be developed and are viewed as "better" than Sunrise.

Kathy Kleiman:Data gathering: what other mechanisms might be available?

Jeff Neuman:There already is a requirement for claims when a name is released. That is already required

Mary Wong:@Jeff, should the question then be whether Sunrise, or an equivalent mechanism, also be required?

Jeff Neuman:Reserved Names is a complicated matter and involves a number of thorny issues because names are reserved for lots of different reasons. This discussion needs to be coordinated with Subsequent Procedures PDP

Jeff Neuman:@Mary - Understood. But this needs to be coordinated with Subsequent Procedures as perhaps a joint discussion.

Mary Wong:We can hear you, Lori

Maxim Alzoba (FAITID):claims are not required ATM for release of names (they required only 90 days following the beginning of GA)

Kathy Kleiman:sorry, just lost my connection :-{

Mary Wong:@Jeff, point taken. We'll note as Action Item.

Maxim Alzoba (FAITID):+1 @Jeff about coordination with Subsequent Procedures PDP

Kristine Dorrain - Amazon Registry Services:+1 Jeff

Mary Wong:@Lori, @Jeff - how about the Sub Team agrees on the rewording (per Kristine) and suggest to the WG that we park this question until it can be discussed with SubPro?

Kristine Dorrain - Amazon Registry Services:My current wording: Are ROs using features like pricing and reserved lists to avoid the sunrise RPM?

Kristine Dorrain - Amazon Registry Services:Which hopefully limits the discussion here to ONLY sunrise issues.

Kristine Dorrain - Amazon Registry Services:Jeff?

Maxim Alzoba (FAITID):RPMs is about not giving names to wrong people  
Mary Wong:@Lori, it depends. An initial discussion with the relevant Chairs (Sub Teams, Work Tracks) would be the start.  
Kristine Dorrain - Amazon Registry Services:Yes  
Maxim Alzoba (FAITID):and not about delivering it to particular parties  
Mary Wong:And yes, sorry, WG chairs obviously too (left that out from my response as a result!)  
Maxim Alzoba (FAITID):but the coordination should be done between whole PDP and not with subgroup and another PDP  
Jeff Neuman:Susan Payne I think was the other  
Mary Wong:@Jeff, for that discussion - if it's on specific questions - inviting the Sub Team and Work Track chairs would be good, won't it?  
Mary Wong:Yes, Susan Payne.  
Jeff Neuman:yes sub-team chairs too  
Kristine Dorrain - Amazon Registry Services:I'm thinking...  
Maxim Alzoba (FAITID):which question are we now on?  
Maxim Alzoba (FAITID):9?  
Maxim Alzoba (FAITID):and what is the final version of 5?  
Mary Wong:@Maxim, Kristine suggested rewording (see above)  
Jeff Neuman:What is the "intended" effect of Sunrise?  
Maxim Alzoba (FAITID):do we know it?  
Roger Carney:+1 Jeff  
Philip Corwin:I would think the intended effect was to give rights holders a fair chance to register as domains those marks that they have placed in the TMCH.  
Mary Wong:For the TM Claims Sub Team, staff went back and looked at the IRT and STI reports and ICANN documents for the AGB to try to find rationale. Shall we do the same here?  
Maxim Alzoba (FAITID):Rightholders are not limited to TMCH  
Roger Carney:@Mary, makes sense  
Maxim Alzoba (FAITID):so we had to have local LRP for the small TM owners  
Kristine Dorrain - Amazon Registry Services:I would love that Mary  
Jeff Neuman:a "fair chance" pr "first chance"  
Jeff Neuman:or  
Maxim Alzoba (FAITID):ASCII in moscow  
Maxim Alzoba (FAITID):and Cyrillic in .MOCKBA  
Kathy Kleiman:I have to run - great meeting, Lori!  
Mary Wong:There's no RPM WG call next Weds so the Sub TEam can use that Weds time rather than Friday, if preferred.  
Maxim Alzoba (FAITID):also there might be a community restrictions  
Maxim Alzoba (FAITID):like only citizens of particular city .. so not all TMCH entries are good  
Lori Schulman:That could work. I have the CCT-RT plenary next Wed. May 10, If it doesn't overlap, I could chair  
Mary Wong:@Kristine, @Maxim - do we know if there is any centralized data location to track all RO LRPs? I'm not sure the ICANN site has that info (but could be wrong).  
Maxim Alzoba (FAITID):yes  
Maxim Alzoba (FAITID):there is good resource for LRPs
