Marika Konings: From the Bylaws: "The EC Administration shall manage and moderate the Approval Action Community Forum in a fair and neutral manner."

Maxim Alzoba:about basic understanding of financial operations for candidates into "5" - they will need to be able "• Approve Fundamental Bylaw and Articles amendments, and Asset Sales "

Maxim Alzoba:to approce asset sales it is good to be aware of the basic ideas in finances

Renata Aquino Ribeiro:so ec rep will approve stuff on community forum w/out going through GNSO council too

Marika Konings:@Renate - no

Osvaldo Novoa:Sorry, I lost my internet connection for some minutes.

Maxim Alzoba:ves

Renata Aquino Ribeiro:tks marika

Maxim Alzoba:at least we need to ask

Osvaldo Novoa: The EC representative cannot take any decision without the GNSO Council authorization.

Renata Aquino Ribeiro: ok so a good communicator y

Maxim Alzoba: before alerting GNSO the candidate needs to understand that there is an issue

Osvaldo Novoa: Just enough to undertand it. But it would be the same for any topic to be discussed.

Renata Aquino Ribeiro:he/she would convey arguments but have no decisional polwer maybe?

Julf Helsingius: There won't be issues to be missed.

Julf Helsingius: The "issue" would be someone asking for action

Osvaldo Novoa: The EC representative is just the way of communication between the EC and the GNSO Council

Renata Aquino Ribeiro:v

Guillemaut:do we have any former ambassador for this role ?,

Marika Konings: Exactly Osvaldo

Renata Aquino Ribeiro:liason?

Guillemaut:someone wnho used to work in a embassy

Guillemaut:un ambassadeur

Maxim Alzoba: I think it is the first time for EC "5" to be summoned, am I right?

Osvaldo Novoa:I think that a fairly inteligent person with good communications skills would be the ideal.

Renata Aquino Ribeiro: i think a good writer would do

Marika Konings:@Renate - no writing involved as the rep to the EC Admin would just pass on the Council motions / decisions.

Renata Aquino Ribeiro:ok

Renata Aquino Ribeiro:so agree w/ osvaldo

Maxim Alzoba:policits are good at not answering while talking, I think there is more of a liasion between , for example GNSO and EC "5"

Poncelet Ileleji:So does this main the individual must have all the prerequisite knowledge of the GNSO prior to taken up this role. So with this its easy to narrow the candidates as it can come from the Chair

Marika Konings:main role is conveying GNSO Council decisions, so familiarity with GNSO Council actions may be key?

Poncelet Ileleji:mean I meant

Osvaldo Novoa:We don't know the work load of the EC representative, I would prefer a person with no position in the Council, in order to be dedicated to this work.

Julf Helsingius: A former council member would probably be perfect

Osvaldo Novoa:+1 Julf

Maxim Alzoba: Who is in charge of assessment of the GNSO candidates for the EC seat? is it just GNSO Council or is it SSC and then GNSO Council?

Maxim Alzoba: if there is more than 1

Marika Konings:@Maxim - SSC is first expected to propose the criteria and process for GNSO Council approval. Following that it would likely ask the SSC to run the selection process following which the Council would confirm the appointment.

Maxim Alzoba:ok

Marika Konings:To clarify further in relation to the community forum, The EC Admin gets to manage the Community Forum but it

doesn't get to decide anything else other than format. Similarly, the Forum itself is NOT a decisional body - it is merely the means by which the EC (all five decisional participants) get to discuss the Approval Action in question.

Maxim Alzoba:Could we suggest inclusion of "letters of support" from GNSO bodies as an additional selection criterion?

Maxim Alzoba:to exclude issues with not-so GNSO candidates (as the last time)

Guillemaut:+1

Julf Helsingius:As long as the NCA's count as a (virtual) body Maxim Alzoba:when we had 3 persons assisiated themself with the GNSO without proper support or affiliation

Julf Helsingius:For the letters of support

Marika Konings: You may first want to discuss whether the chair is the default or the back-up, and then in either case determine what the criteria are for any other person that may want to be considered?

Maxim Alzoba:I think it is up to GNSO Council to assess if the support is good enough for GNSO

Julf Helsingius:probably too detailed, yes

Maxim Alzoba:could we limit now to the "basic idea - to mark who has GNSO affiliation and support" and we supply GNSO Council with that ... so they can make better choice

Renata Aquino Ribeiro:a support to the chair

Renata Aquino Ribeiro:chair would be an emergency intervention Marika Konings:note that in a GNSO Council context, there are also the Council vice-chairs that could be considered?

Renata Aquino Ribeiro:sorry susan, to explain myself more clearly: not really putting chair up to this but to oversee whoever will do this

Maxim Alzoba:I think that the person is up to GNSO Council ... so all we can do -is tp suggest what to do in situation where Maxim Alzoba:they might need other selection

Maxim Alzoba: than the GNSO Chair (for whatsoever reason they might have by that time)

Renata Aquino Ribeiro: y workload increase is on the horizon Marika Konings:doodle poll for a next meeting next week? Marika Konings:yes
