Membership status: Any interested person can join the association, once all the formalities and forms have been completed. All members of the chapter will also be members of the Internet Society.

There are 4 categories of members:

- **Number members: they are approved by the board of directors, they pay social quota and they are registered in the book of the association.**
- **Honorary Members: national or foreign persons who show relevant achievements in activities related to the Internet or ICTs**
- **Cooperating Partners: natural or legal persons related or sympathizers with the aims of the association who want to contribute economically.**
- **Student members: students from educational institutions of the Paraguayan state and who have their residence in Paraguay. They have all the rights, except the vote, do not pay social quota.**

The General Assembly constitutes the maximum authority of the Association.

The Management and Administration of the Association is in charge of a Board of Directors, composed of a President, a Vice President, Secretary and Treasurer, appointed by the General Assembly, which may remove them for serious reasons.
