Berry Cobb:@Phil - yes. It is now part of GNSO Op Procedures as part of DMPPM recommendations. Impact analysis on proposed recommendations.

Berry Cobb:Data & Metrics for Policy Making. A WG concluded in 2013. About data driven analysis in policy development.

Mason Cole:Feedback on the line

George Kirikos:Someone's slurping a drink?

Mary Wong:sorry I'm having connectivity problems

Paul Tattersfield:Steve what are you classing as "their domains"?

George Kirikos:I understand the idea of a risk assessment. Just concerned about ICANN staff doing self-directed data collection/analysis, that hadn't gone through the working group members first.

Mary Wong:the staff research is supposed to assist with the risk analysis the WG agreed to last week and that steve just clarified

Berry Cobb:I'll defer to next week, please. I'm not dialed in.

George Kirikos:Staff are here to support the working group, and shouldn't be doing independent/self-directed research, in my view.

Paul Tattersfield:Is there a list of the 192? IGOs that the GAC wanted to "protect"?

Mary Wong:paul, yes - it's the GAC list from 2013 that is out predecessor wg looked at and used too

Paul Tattersfield:thanks Mary, has there been any updates to it?

Mary Wong:paul, no

Mary Wong:note that this is a staff draft meant to facilitate WG discussion and not intended as conclusory or any sort of staff view

Paul Tattersfield:I think it's also worth noting he articles of the IGO's require them to settle disputes in an appropriate forum this doesn't necessarily mean only the forum that the IGO chooses.

Paul Tattersfield:mean

George Kirikos:Same for country-code TLDs.

Petter Rindforth:Again, a separate DRP seems to be an easy way in the first thought, but once anyone study all the details it seems more difficult to create and to work in a practical and acceptable way

George Kirikos:+1 Petter.

George Kirikos:US Govt was also concerned about "fake" IGOs.

George Kirikos:Small group proposal was sloppy, confusing and/or in a few places, etc., i.e. not just "forum shopping", but legal test shopping.

Paul Tattersfield:That's another list I think it would be helpful to see George

George Kirikos:Indeed, Paul.

Mason Cole:need to head to another call. see some of you in jo'burg. thanks Petter and Phil.

Petter Rindforth:See you there!

Mary Wong:on the down how negative in point 3, I think we could have phrased it better as a drp that is "based on something other than trademark rights" (instead of "not on trademark rights"). sorry for the confusion.

George Kirikos:Option 2 is not best for the domain owner!

Mary Wong: ** double (not down how)

George Kirikos:Is anyone supporting a separate DRP? Perhaps a straw poll?

George Kirikos:X to oppose?

Petter Rindforth:George, I see your hands up ;-)
