



Review Timeline



Then:



- +/- 3 months OEC considers the Final Report, Feasibility Assessment and Public Comments. Makes recommendation to the Board re: action on each recommendation.
- +/- 2 months Board takes action on the recommendations. Implementation planning and work begin.
- +/- 18 months Implementation team is formed, implementation takes place supported by ICANN org.



Roles & Responsibilities Until Submission of Final Report

Review Working Party

- ✓ Input into review scope and IE selection criteria
- Community outreach support
- ✓ Input into data collection – online survey and interviews
- Provide clarification and factual corrections throughout the review

Independent Examiner

- Lead RWP calls
- ✓ Assess
 effectiveness of
 prior review
 improvements
- ✓ Review of documents, records
- ✓ Observe proceedings
- ✓ Develop and conduct surveys / interviews
- ✓ Formulate factual observations and implementable recommendations
- Engage with stakeholders for clarification and correction
- Prepare report(s)

OEC

- Provide oversight
- ✓ Approve scope of review
- ✓ Confirm selection of independent examiner
- Monitor review progress

ICANN org

- Facilitate review process
- Prepare RFP, run competitive bidding process
- Select independent examiner in accordance with selection criteria
- Monitor timeline and resources
- Support outreach and engagement
- Manage public consultation and public comment processes



Roles & Responsibilities Post Submission of Final Report

Review Working Party

- Establish RWP's level of agreement with Final Report (FR)
- Assess feasibility of recommendations
- Provide proposed alternatives if there is a disagreement with the feasibility of the IE's recommendations
- Provide detailed rationale for each rejected assessment or recommendations Based on above work, compile Feasibility Assessment and Initial Implementation Plan (FA)* – ICANN org provides template
- Present FA to OEC

*contains provisional budget implication, anticipated resources, and timeline.

Implementation Team*

- Draft detailed implementation plan, based on direction provided by ICANN Board
- Conduct implementation of recommendations that require community action
- Support / monitor implementation of recommendations that require ICANN organization action
- Provide OEC with semi-annual updates
- Provide OEC with final implementation report once efforts are completed

*formed after Board action

OEC & ICANN Board

- OEC receives FR and FA
- IE and RWP present FR and FA to OEC
- OEC assesses FR, FA, all other relevant documentation, makes recommendation to Board on next steps
- Board accepts FR* and FA, takes decision on next steps
- OEC oversees implementation, receives semiannual updates and final implementation report

*resets the five-year clock until next review

ICANN org

- Provide template for Feasibility
 Assessment and Initial Implementation Plan (FA)
- Support work of RWP
- Facilitate IE and RWP presentations to OEC
- Support work of implementation team
- Implement recommendations that require ICANN org action.
- Support drafting of semi-annual implementation reports and final implementation report



Considerations for the RWP

- Will the RWP continue in its current composition for the feasibility assessment?
- Will the RWP 'morph' into the implementation team?
- Are there any concerns or questions about the timeline?
- Are there any concerns about the roles and responsibilities post submission of Final Report?
- Are there any concerns about the implied work commitment?
