Rubens Kuhl:Not that they were asked how much would be safe, but were asked if 1000/year would be safe, and all said yes.

Kavouss Arasteh:What is the justification for that limit be the maximum?

Maxim Alzoba (FAITID):I think it was just guess , without much of justification

Rubens Kuhl:There is none. This number was posed as an incredibly high optimistic view of the number of applied-for strings.

Kavouss Arasteh:Suppose 3000 application came in and 2500 of them successfully examined and terminate the process but ICANN should not delegate more than 1000 of that why? how that 1000 are selected among the e 2500 which successfully applied the provcess in the example that I gave

Rubens Kuhl:The only hard limit from that time, which is probably invalid nowadays but was once valid, was the 100,000 total TLD delegation limit.

Annebeth Lange:Anne, yes

Rubens Kuhl:Kavouss, if that happened, 1000 would be delegated one year, 1000 the next year, 500 the last year.

Maxim Alzoba (FAITID):as far as I know, last few yeas it was GAC and ccNSO separate efforts, mostly not synced

Annebeth Lange:Kavouss, I think the plan is to have a co-chair from AC/SOs - and as many participants as possible to share their competence

Greg Shatan:The "one from each" applies only to leadership of WT5, not to participation.

VANDA SCARTEZINI:@ Annebeth yes, there is no limit to

participation.

Maxim Alzoba (FAITID):could we say - that co-chair seats are reserved for the representatives of the SO/AC?

Rubens Kuhl:Except having an SOI, which is the only requirement for every GNSO PDP.

Annebeth Lange:And of course,what we hope, is that as many as possible also from GAC, ALAC and ccNSO will participate
