Trang Nguyen: (06:58) @Alan, thank you for the clarification. I see it now. This is not expected behavior. The tool performs the lookup and parses data retrieved from registry/registrar. Blanks could mean either an issue with the parser or with information from the registry/registrar. We will ask the ICANN technical team to look into this.

Carlton Samuels: (07:02) @Susan: See the 2013 RAA obliges standard format for wWHOIS data IF you sell new gTLDs.

Carlton Samuels: (07:03) @Alan: BUt IF you sell domains in new GTLDs almost ALL WHOIS obligations of 2013 RAA apply!

Alan Greenberg: (07:04) @Carlton, yes, but the vast percentage of business (and 100% for some registrars) is in old ones.
