Laureen Kapin: (09:44) ICANN must regularly conduct a publicly-available comprehensive analysis of technical abuse in the DNS (to include phishing, malware hosting, botnet command and control, and spam). Such analyses should build upon the CCT Review Team's DNS Abuse Study and identify the rates of abuse in all legacy and new gTLDs, correlating the rates to registries, registrars, and resellers, including cross-TLD common entities. Furthermore, these studies should correlate abuse rates to registration restrictions, registry and registrar agreements, and other distinguishing variables.
