# Review of Recommendations and Responses

#### Issues

Does this reflect the consensus of At-Large?

 Is what we are committing to practical and implementable?

#### Be selective on Advice

- Support noting we already are selective
- But we note our web/wiki does not fully reflect this, or differentiate type of statements

#### Adopt Empowered Membership Model

- Reject recommendation, but
  - Accept the need to increase focus on individual members
  - Also must focus on <u>members</u> of ALSes
  - Reject merger of ALAC/Regional leaders/Liaisons and freeing up travel slots
  - Accept the need to increase opportunities for active policy workers to travel
  - Uniform Individual Members rules \*may\* be a target, but not a priority
  - We do not accept the "Council of Elders" but accept that recognition of former active members may be valuable
  - Reject concept of appointing leaders and other positions using random selection

Staff to more actively support policy activities in relation to administration activities

- Support in principle, but reject thesis that current activity is not reasonably appropriate
- ALS communication plan will increase staff involvement
- Also need more admin support (such as note taking at meetings)

Dissolve ALT and return decision making to ALAC

 Reject: ALT does not make decisions and is a purely advisory body to Chair ensuring regional balance and multi-facetted input.

Redouble efforts to join meetings between ICANN senior staff and I\* leaders

- Support noting:
  - We are not invited to such meetings
  - If we were, we would attend
  - That notwithstanding, we have a lot of such interactions at operational levels

#### Simplify At-Large Director selection process

- Reject
  - Developed by bottom-up process
  - Will no doubt evolve
  - Not the Board's business how we select our Board member as long as there is no evidence of capture.

#### **Abolish all Working Groups**

- Reject
  - Note web/wiki badly need updating and clarification

Use Social Media more effectively to engage and poll users

- Supports intent
  - Concerns with accessibility
  - Concerns with representativeness of feedback

Designate staff as "Web Community Manager" to coordinate social media outreach

- Support intent
  - Already partially in place
  - Staffing not our responsibility

Use new communications tools ("Slack-like")

- Support with reservations
  - Diverse community with diverse requirements and limitations
  - Support of tools generally requires ICANN IT commitment
  - That's why we have the TTF

Replace ATLAS with five regional meetings every 2-3 years

- Reject
  - ATLAS important to ensure that we do not work purely in regional enclaves
  - 5 meetings in 2-3 years = 2 GAs per year
    - Load on volunteers and staff

Outreach through participation in more regional meetings

- Support
  - ALAC notes implementation implies significant funding

Clearly publicise travel funding opportunities and beneficiaries in one place

- Support in principle
  - But not wise to duplicate information
  - Transparency of beneficiaries/benefits should not be limited to At-large, but for the entire organization including the SOs, Review Teams, the Board and ICANN staff.
  - ICANN must take into account COST to volunteers as well as benefits received.

Request use Auction funds to for At-Large operational expenses from CCWG Auction Funds

- Reject
  - Counter to projected use of funds
  - CCWG is not empowered to grant such a request

Send "Outreach Rapporteurs" to ICANN meetings

- Reject with qualification
  - Unclear what outreach rapporteurs are or what they would do at ICANN meetings
  - There are at time outreach opportunities at ICANN meetings and ALAC should consider them where applicable. Indigenous peoples fellowship an example.

Adopt Metrics for entire At-Large Community to measure impact of EMM

- Support with qualification
  - The ALAC rejects the EMM, but nevertheless supports metrics
  - Already some in place
  - Metrics for non-leader contributions difficult, but
     ALAC intends to once again try to address this.
