Carlton Samuels: (09:35) Here's Spec 11(3)(a) &(b) of RAA 2013 which registrars must comply if they sell new gTLD domains:Registry Operator agrees to perform the following specific public interest commitments, which commitments shall be enforceable by ICANN and through the PICDRP. Registry Operator shall comply with the PICDRP. Registry Operator agrees to implement and adhere to any remedies ICANN imposes (which may include any reasonable remedy, including for the avoidance of doubt, the termination of the Registry Agreement pursuant to Section 4.3(e) of the Agreement) following a determination by any PICDRP panel and to be bound by any such determination. a. Registry Operator will include a

provision in its Registry-Registrar Agreement that requires Registrars to include in their Registration Agreements a provision prohibiting Registered Name Holders from distributing malware, abusively operating botnets, phishing, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engagin

Jonathan Zuck: (09:36) did someone capture Jordyn's comments on the list?

Carlton Samuels: (09:36) Now Daid is gone altogether!

Carlton Samuels: (09:38) @David: To me the question is how would a reasonable person know if these commitments are worthwhile? Answer: You count. How do you count? Let us count the ways. What is the evidence of enforcement? That is the question!

Carlton Samuels: (09:40) Again, is it possible to have individual scrolling rights to the paper?

Drew Bagley: (09:43) @Carlton - the language you pasted requires registry operators to require registrars to include certain language in their agreements. This requirement is different from our recommendation. We are going beyond a mere language requirement.

Drew Bagley: (09:55) @Carlton - Recommendations 1 and 2 are in response to situations such as those because there current exists no means to deal with systemic abuse

Carlton Samuels: (09:55) They did the sensible thing of tacking their meaning of abuse to ICANN's overall remit.
