There may be instances where our suggested "gap filling" may not be clear or appropriate in the IRT's view, hence we are grateful for the IRT's feedback to ensure that the agreement and provisions reflect the PDP recommendations (as Caitlin is now saying).

Darcy Southwell:@Caitlin, the difficulty with that approach is that we don't know what came from the PDP and what is suggested by "some" IRT members.

Mary Wong:@Darcy, perhaps the most appropriate and comprehensive approach - to ensure that the PDP recs are properly and accurately captured - is what we have assumed the IRT has been doing, i.e. going through all the documents section by section (so regardless of who suggested what and where).

Vicky Sheckler: thanks Mary- important to make sure we are in line w/ the pdp recommendations

Sara Bockey: I will need time to review the edits in the PPAA that you sent out last night before providing further comment. Thanks

Volker Greimann - RrSG:I object to change the language. Lt's stick to what is in the RAA

Sara Bockey: And I agree with Volker. I'd like to stick with what is in the RAA re definitions.

Volker Greimann - RrSG:3.14 Obligations Related to Proxy and

Privacy Services. Registrar agrees to comply with any ICANN-adopted Specification or Policy that establishes a Proxy Accreditation Program. Registrar also agrees to reasonably cooperate with ICANN in the development of such program. Until such time as the Proxy Accreditation Program is established, Registrar agrees to comply with the Specification on Privacy and Proxy Registrations attached hereto.

Volker Greimann - RrSG: this should be all that is needed. and as it is already in the RAA, there needs to be no mention in the policy

Volker Greimann - RrSG:sec, wrong qote ;-)

Sara Bockey: The definitions in the Final Report mirror the RAA Volker Greimann - RrSG: The thinking on my part was that the only reason to differentiate was not to overregulate affiliated providers who have to do many of the things already trhough their registrar agreement

Volker Greimann - RrSG:and agreed to Sara re: this program is way overdesigned in many respects

Volker Greimann - RrSG: there is so many reviews and process steps that are not necessary for this service and that just serve to drive up costs

Darcy Southwell:+1 Volker about the obligations that will be performed by the affiliate registrar
