Summary of the main records of ccTLDs.

Not included yet is the terminology used over time to describe the removal/retirement in the different detailed IANA reports and ISO records. For example, in the case of .um, the *.UM delegation be removed* and that *.UM be returned to the pool of unallocated ccTLDs*. In the .AN related report the following terms are used: “*disposition*” of .AN top level domain and “*retired*”.

The terminology in use in the high –level overviews is **marked**.

- .UM case

 - At request of ccTLD manager and government
 - No registrations at time of request and decision (2007)
 - Current status in <https://www.iana.org/domains/root/db>: **Not assigned**
 - Current status ISO 3166-1: **Assigned**
- .AN case (Netherlands Antilles)
 - IANA report: <https://www.iana.org/reports/2011/cw-report-20111003.html>
 - Netherlands Antilles ceased to exist, after restructuring of Kingdom of Netherlands (2010)
 - Retirement Part of delegation of .CW delegation process 2010
 - Closure of retirement process in 2015.
 - Current status IANA Root Zone Database: **retired**
 - Current status ISO 3166-1: **Transitionally reserved** (assigned-> transitionally reserved). Additional Information: The Netherlands Antilles was divided into Bonaire, Saint Eustatius and Saba (BQ, BES, 535), Curaçao (CW, CUW, 531) and Sint Maarten (Dutch part) (SX, SXM, 534).
- YU (Yugoslavia)
 - IANA report on .YU retirement itself included in combined delegation and retirement report: <https://www.iana.org/reports/2007/rs-yu-report-11sep2007.html>
 - Break-up of Yugoslavia
 - Part of delegation of .RS delegation process
 - Process initiated in 2007 (with the delegation of .rs) and completed in 2009

- Current status IANA Root Zone Database: **not included in IANA Root Zone Database, no record in** <https://www.iana.org/domains/root/db>
 - Current status ISO 3166-1: **Transitionally reserved** (from assigned-> transitionally reserved) Additional information: Name changed from Yugoslavia to Serbia and Montenegro (CS, SCG, 891) in 2003. Former Yugoslavia was divided into Bosnia and Herzegovina (BA), Croatia (HR), The former Yugoslav Republic of Macedonia (MK), Serbia and Montenegro (CS), Slovenia (SI).
- TP (Portuguese Timor)
 - “TP” two-letter ASCII code designated for Portuguese Timor in 2002. The successor country, Timor-Leste, was granted a new two-letter ASCII code of “TL”.
 - IANA Root Zone report: <https://www.iana.org/reports/2015/tp-report-20150126.html>
 - Process for removal was initiated and concluded with removal from the root of .TP in February 2015.
 - Current status IANA Root Zone Database: **not included in IANA Root Zone Database.** However, recoded in <https://www.iana.org/domains/root/db> as **retired**
 - Current status ISO 3166-1: **Transitionally reserved** (from: assigned-> transitionally reserved). Additional Information (informational): Name changed from East Timor (TP, TMP, 626) to Timor-Leste (TL, TLS, 626).
