Cheryl Langdon-Orr:I am only on AC now had to join another meeting via phone bridge

Jon Nevett:.doctor?

Jon Nevett:based on what data, Alan?

Holly Raiche 2:Agreed with Alan - the draft CCRT report does talk about consumer expectations

Gg Levine (NABP):Well said, Alan

Michael Flemming:Sorry for the background noise if I had made any

Phil Buckingham:how do we determine a regulated industry ? they may vary country by country ?

Jeff Neuman:I yield to Gg and Alan

Alan Greenberg:I was not advocating ANYTHING. I was asked to present the ALAC position and that is what I did.

Jeff Neuman:i would like to hear Alan's view now

Heather Forrest:Michael - put yourself in the Qto hold your place

Alan Greenberg:Why is it I have REPEATEDLY been told that we are not trying to make decisions during this review of comments?

Heather Forrest:chemist

Jeff Neuman:We are not making decisions, but we are debating the issues

Cheryl Langdon-Orr:thanks for the clarification Michael

Jeff Neuman:So, Alan, can you put yourself back in the queue?

Holly Raiche 2:Agree with Jeff - that is the issue that was raised by the CCRT report - the issue is how to deal with consumer expectations and whether ICANN rules take those into account - just an aspect of public interest

Alan Greenberg:I am mystified why in other WT meetings, I was

told that the methodology, I think developed by Avri, that we were reviewing comments and NOT trying to resolve conflicts or come to closure.

Jeff Neuman:I would note that there is a difference between "a connection" and "expectation of safety"

Alan Greenberg:I did not come to this meeting prepared to debate the issues.

Holly Raiche 2:Agree with Jeff - just raising the issue of how we deal with expectation and connection

Jon Nevett:Right Jeff ex-ante censorship vs. ex-post enforcement

Holly Raiche 2:I think the idea of the categories was to identify the critical names such as doctor and pharmacy

Jim Prendergast:you went there!!

Michael Flemming:I did

Jon Nevett:i agree with Alan!

Holly Raiche 2:Could this be sent out

Phil Buckingham: dont think so michael

Holly Raiche 2:sorry - 'sent'

Julie Hedlund:We will send it with the notes and also post to the wiki.
