# Cross Community Working Group (CCWG) on new gTLD Auction Proceeds

## Legal and Financial Considerations

The establishment of a Cross-Community Working Group to develop principles for allocation of the proceeds of the New gTLD Program last-resort auctions is consistent with ICANN's commitment to community participation in determining how those proceeds are used.

As part of ICANN's participation in the drafting team, ICANN is providing a memo that outlines some of the issues that will impact how ICANN can disburse the New gTLD Auction Proceeds. Because of the legal and financial restrictions that ICANN will have to take into account when disbursements are made, this memo is provided as a starting point to identify the considerations that could guide the CCWG in its work and that might be appropriate for reference in the CCWG's Charter.

# Cross Community Working Group (CCWG) on new gTLD Auction Proceeds

## Legal and Financial Considerations

The purpose of an auction is to resolve contention in a clear, objective manner. It is planned that costs of the new gTLD program will offset by fees, so any funds coming from a last resort contention resolution mechanism such as auctions would result (after paying for the auction process) in additional funding. Any proceeds from auctions will be reserved and earmarked until the uses of funds are determined.

# Cross Community Working Group (CCWG) on new gTLD Auction Proceeds

## Legal and Financial Considerations

*Funds must be used in a manner that supports directly ICANN's Mission and Core Values and also allows ICANN to maintain its not for profit status.*

*Possible uses of auction funds include formation of a foundation with a clear mission and a transparent way to allocate funds to projects that are of interest to the greater Internet community, such as grants to support new gTLD applications or registry operators from communities in subsequent gTLD rounds, the creation of an ICANN-administered/community-based fund for specific projects for the benefit of the Internet community, the creation of a registry continuity fund for the protection of registrants (ensuring that funds would be in place to support the operation of a gTLD registry until a successor could be found), or establishment of a security fund to expand use of secure protocols, conduct research, and support standards development organizations in accordance with ICANN's security and stability mission.*

1. Consistency with ICANN's Mission as Set out in the Bylaws
  2. Private benefit concerns
  3. Must not be used for political activities
  4. Should not be used for lobbying activities

  7. Financial and Fiduciary Concerns

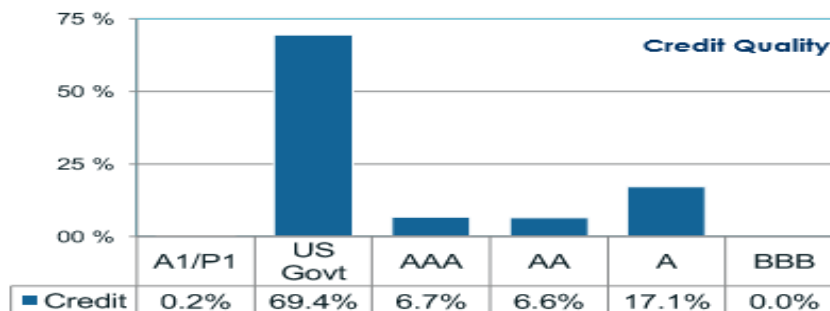

## Proposals Within the Remit of ICANN Mission

The proposed objectives for fund allocation by the CCWG are:

Specific objectives of new gTLD Auction Proceeds fund allocation are:

- (1) Benefit the development, distribution, evolution and structures/projects that support the Internet's unique identifier systems;
- (2) Benefit capacity building and underserved populations, and;
- (3) Benefit the Open Internet [Open Internet and Interoperable Internet on a separate slide]

New gTLD Auction Proceeds are expected to be allocated in a manner consistent with ICANN's mission.

## Proposals Within the Remit of ICANN Mission

## **Open Internet/Open Interoperable Internet Definition**

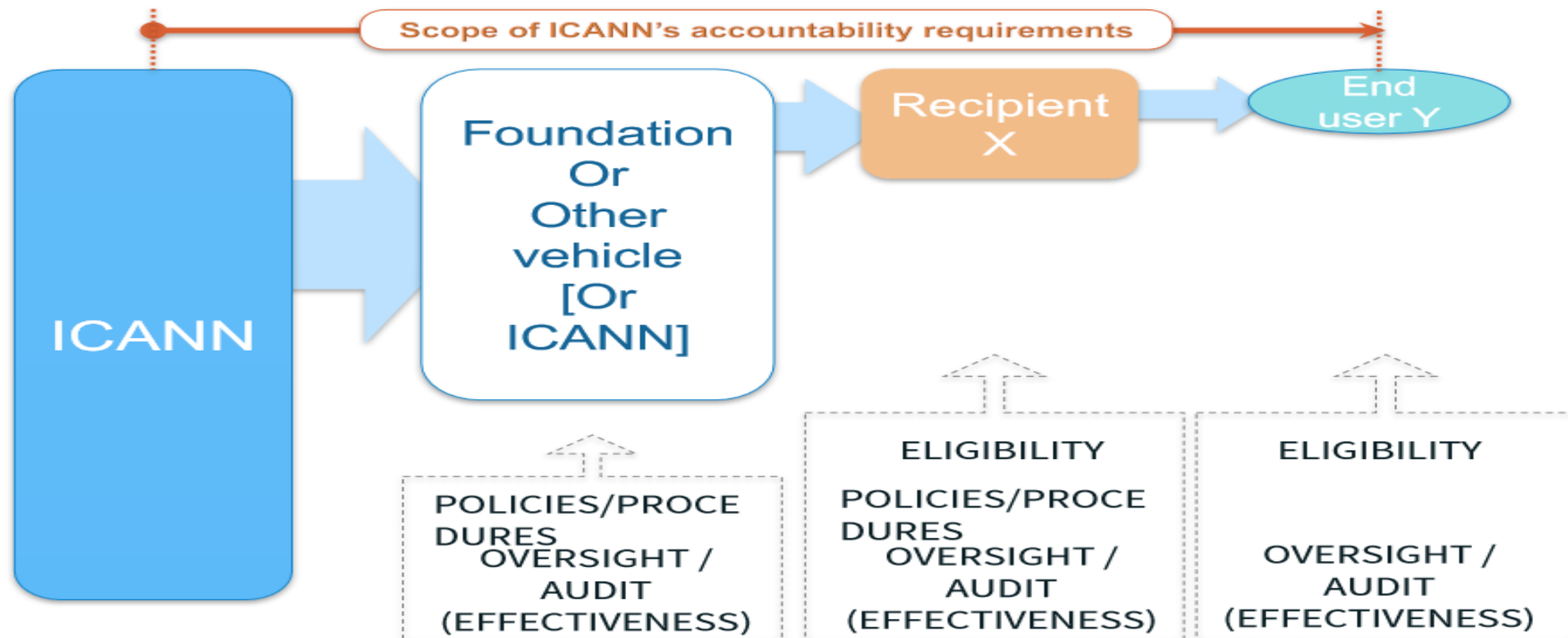
A small group has volunteered to draft, produce the definition of *Open and/or Interoperable Internet*, as agreed by the members of gTLD Auction Proceeds.
