1. ***What guidelines does your group have for supported travelers? How do these differ from the ICANN Community Travel Support Guidelines?***

NARALO has travel slots for the Chair, Secretariat, ALAC and NOMCOM persons

We also have five local travel trips via CROP. This is different than the GNSO which permits one trip outside the region per year. We have spoken to Mary Wong on the merit of ATLARGE having a similar provision

2. What aspect of the current ICANN Community Travel Support Guidelines work well for your group?

The provision of economy travel works well for our community..

3. What specific area of the ICANN Community Travel Support Guidelines affect your group the most?

4. What area might be added to the ICANN Community Travel Support Guidelines to provide additional support to your group?

What is missing is concentrated and focused ICANN regional events that we are not invited nor sponsored to participate. Secondly many events ie. IGF's, RightsCon etc are events that ICANN staff are sponsored and are panelists on multistakeholders but they ignore our participation

5. How does your group allocate its community travel support slots? How are members prioritized? How are newcomers to ICANN considered?

We have had 10 years and 1000 fellows sponsored with a total disregard of North American until this year which is four NARALO ALS members who are attending ICANN 60. I think sponsorship of other ALS members is critical since we have an obligation to build capacity and provide policy statements, its critical to encourage new travellers to understand more intimately the ICANN ecosystem. Suggest we integrate the fellowship into community participation. The community should be charge of selecting these individuals

6. What, if any, educational and informational activities does your group conduct to inform participants of ICANN community resources?

We have a monthly NARALO newsletter in Constant Contact, monthly meetings, special purpose Hot Policy topic discussion and orientations sessions for membership

We have produced in Ebooks ICANN on boarding materials etc

7. What are actionable and measurable expectations your group or leadership has for members who receive travel support? Are there follow-up reporting requirements for members who attend ICANN Public Meetings and/or receive Community Regional Outreach Program (CROP) funding?

All Crop persons complete a report within four weeks. Secondly we send a follow up survey to all CROP traveller on their lead generation.

ATLARGE used to have daily reporting but this has disappeared

NARALO produced two reports to community on progress and developments

NARALO newsletter has reporting of ICANN meetings

NARALO fellows for ICANN 60 are asked to do daily blogging

8. Instead of reimbursement for travel-related expenses, would your members prefer to receive a stipend or per diem from the ICANN organization?

We get a per diem but the Canadian bank charges an extra wire transfer fee which results in a loss

9. Are there categories of travel and events that you are not presently able to support?

All local ICANN events in North America should include NARALO membership and sponsored

10. How does your group plan for upcoming events? What is your planning cycle for deciding on whether ICANN community or organization resources might be used?

We have a very small discretionary fund of 2,000 per RALO which has limitations and designed for local events. This spread across a year and 25 ALS is small funding.

We have a CROP strategic plan authorised by the GSE
