RDS/WHOIS1 Review Team's Recommendation 3: Outreach

ICANN should ensure that WHOIS policy issues are accompanied by cross-community outreach, including outreach to the communities outside of ICANN with a specific interest in the issues, and an ongoing program for consumer awareness.

ICANN Board Action

- ⦿ The Board directs the CEO to have staff create an information portal with clear explanation of how to access the existing WHOIS information. The portal will also make it clear how to notify relevant parties of a data accuracy issue.
- ⦿ The Board directs the CEO to have staff create and execute a communication and outreach plan that provides key stakeholders, including users, with the information they need to use, and help improve, the collection and maintenance of gTLD registration data.

ICANN Board's Rationale for Board Action

- ⦿ The WHOIS information for domain names and IP registries is highly distributed. A single portal will make it easier to access WHOIS information, raise accuracy issues about WHOIS information, and allow contributions on WHOIS policies.
- ⦿ In addition to supporting the use of WHOIS, communication and outreach is necessary to inform discussions of the fundamental questions raised by actions related to Recommendation 1.

Outreach Activities

whois.icann.org portal

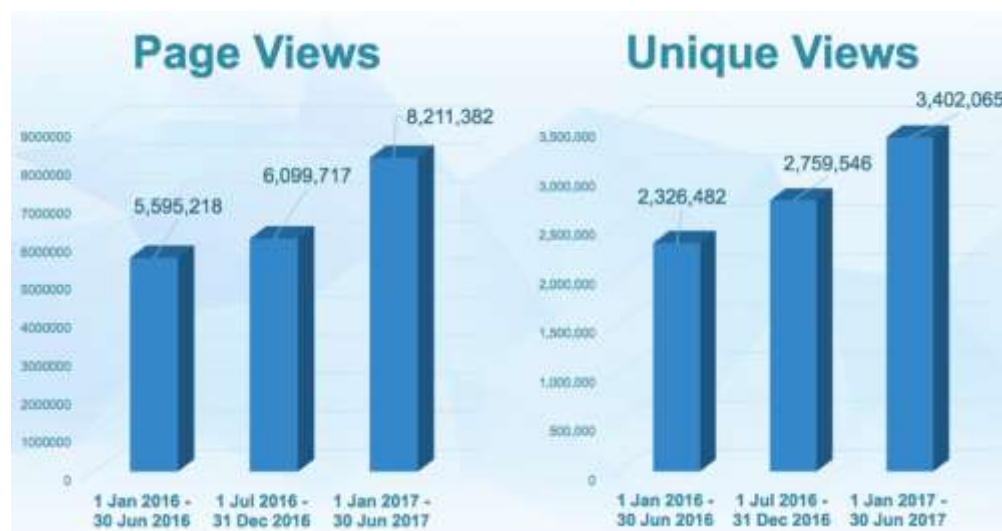
A whois.icann.org portal was launched in 2013. The portal served as a centralized location for all WHOIS information, making it easier to learn about WHOIS, raise accuracy issues about WHOIS information and how to contribute to WHOIS policies. The portal is fully translated in the 6 UN language plus Portuguese. Specifically, the portal:

- ⦿ Provides an overview of WHOIS
- ⦿ Consolidates WHOIS policy documentation
- ⦿ Provides mechanisms for people to submit complaints as they relate to WHOIS data
- ⦿ Directs people to the appropriate channels to become engaged in the community on WHOIS-related topics
- ⦿ Educates Registrants on WHOIS, their rights, and responsibilities
- ⦿ Provides a knowledge center where key WHOIS-related documents can be located

A [WHOIS Primer](#) is also provided on the portal, which provides an introduction to WHOIS, its uses and requirements, dispute resolution procedures, and ongoing work to update or modify the WHOIS program.

This portal also offers a WHOIS look-up tool that allows users to find WHOIS data about any top-level and second-level domains registered on any gTLD under contract with ICANN. A link to report inaccurate data is available on the results page.

In the first six months of 2017, there were 8,211,382 page views of the portal, a 35% increase in page views over the previous six-month period. Of the 8,211,382 page views, 3,402,065 were unique views.



WHOIS Portal Availability

Uptime for the WHOIS Portal has remained at 99.99% - for the last 30 days, 90 days and 365 days. Uptime information is available on the [Accountability Indicators](#) page, Objective 3, then goal 3.2.

Registrant education

ICANN provides registrants [with educational materials](#) to educate and inform them of their rights and responsibilities, the domain name ecosystem and how to navigate it, and the ICANN policies that impact them. One of the topics of the educational materials is [information](#) on the WHOIS Data Reminder Policy (WDRP) and the importance of keeping registration contact information up-to-date. ICANN org continues to provide and update educational materials for registrants. The materials are written for registrants and are translated in the 6 U.N. languages.

Registrar education

ICANN org offers Registrar training to all applicants and existing registrars via LEARN.ICANN.org. The ICANN Registrar Engagement team also provides one-on-one training for Registrars.

Updates on WHOIS related activities to ICANN community

ICANN org regularly provides updates to the ICANN community on the status of various WHOIS related activities at ICANN meetings. Links to these status update sessions are provided in the Useful Links section of this document.

Estimated ICANN Org Time Spent for Implementation

Content development and implementation of both the WHOIS portal and look-up tool took approximately six (6) months and 1.5 FTEs to complete.

Registrant educational activities are ongoing. There is one fully-dedicated FTE supporting the registrant program. In addition, there are work by various other departments and SMEs from across the organization in support of registrants.
