RDS PDP WG Poll - 5 December

During our <u>5 December meeting</u>, the RDS PDP WG begain deliberation on **Domain Name Management** as a possible legitimate purpose, working from the <u>purpose document produced by drafting team 2</u>. The WG deliberated on the definition of this purpose, whether Domain Name Management is a legitimate purpose for collecting some registration data, and (briefly) the registration data needed for this purpose.

This poll gives all WG members an opportunity to consider and express their views about a proposed WG agreement that surfaced during this call.

Note that we are using a building-block approach to reach points of rough consensus on our charter question of "Purpose:" As such, any agreement on the legitimacy of collecting data for this one purpose does not preclude additional purposes being agreed as legitimate for the same or other data. Those on the 5 December WG call expressed support for the following statement; no objections were raised on the call: Domain Name Management is a legitimate purpose for collecting some registration data.

Initial agreement during the call was based on the following definition of Domain Name Management produced by the drafting team:

Information collected to create a new domain name registration and ensuring that the domain registration records are under the control of the authorized party and that no unauthorized changes, transfers are made in the record.

Later in the call, an extended definition of Domain Name Management was also proposed:

Information collected to create a new domain name registration, <u>enabling management of the domain name registration</u>, and ensuring that the domain registration records are under the control of the authorized party and that no unauthorized changes, transfers are made in the record.

In considering these, you may also find is useful to refer to the EWG Report definition which the drafting team started from:

Creating, managing and monitoring a Registrant's own domain name (DN), including creating the DN, updating information about the DN, transferring the DN, renewing the DN, deleting the DN, maintaining a DN portfolio, and detecting fraudulent use of the Registrant's own contact information.
