

Q2 Registration Data needed for Domain Name Management: Based on the following agreed definition of Domain Name Management:Information collected to create a domain name registration, enabling management of the domain name registration, and ensuring that the domain registration records are under the control of the authorized party and that no unauthorized changes or transfers are made in the record. Those on the 12 December WG call discussed the following statement with a mixture of agreement and disagreement: The following information is NOT needed for the purpose of Domain Name Management: Technical Contact, Administrative Contact, Registrar Abuse Contact. To inform further WG deliberation on data needed for this purpose, we will not limit this week's poll to testing the above proposed WG agreement. Instead, this poll question examines your level of agreement with all data needed (essential) to perform Domain Name Management tasks. Please focus your response on data that is essential for this purpose. Additional data which may be useful but not essential will be deliberated separately. In this poll, the term "collection" includes not only data collected from registrants, but also data derived or implied or otherwise supplied by the registrar or registry. Do not assume that collection implies public or nonpublic access to that data or who will have access; this will be deliberated separately later. 7	I do believe that Technical Contact, Administrative Contact fields are required for domain management, these fields are not required on a registration stage in case of "no delegation", where no name servers are added. But the later stages of domain name management, when name servers are added require someone to be able to answer technical questions (Tech) and someone who is able to answer administrative questions (Admin). I think that Registrar Expiration Date is not based on domain name cycle of the TLD (unlike registry expiration date), and thus does not belong here. In case where a registrar does not have enough money on account, auto renewal might not work and thus Registry expiration date would be the one ruling the outcome. The Original Registration date is not required for domain name management (Registrant does not have to know it, registry might not have information about it, at least many current domains does not have this information stored in registries or registrars and we will not have true/accurate information if such idea comes into RDS as a separate field). Registrars have obligation to publish registrar abuse contacts on their website (RAA 2013 requirement), and thus I am not sure multiple records of the same field would help. Registrar URL would be better option to prevent search on IANA / ICANN website in a search of a website of a registrar.
