J. Scott:I agree. I think just asking Did you run a sunrise? If not why?

J. Scott:@Kristine - that makes sense to me

J. Scott:Move to Registrars: Did you participate in Sunrise periods. If not, why?

Mary Wong:Note that the final output from this Sub Team (whether in question form or otherwise) will be passed to the selected vendor, who may have questions that can be funneled back to this group.

Lori Schulman:Mary, your point is noted.

Lori Schulman:We should aspire to the dream.

Mary Wong:@Kristine, that's fine - we will not touch the document until after you and the Sub Team are done for today.

Mary Wong:@J Scott, perhaps this is a question that can be reworked by the vendor?

Philip Corwin:Answering affirmatively would likely be an admission against interest

Mary Wong:From the staff perspective, it remains important for the Working Group overall to be aware of the possibility that some of the survey questions may not elicit any, or any useful, answers - as that may impact the rate of response in the first place.

Kathy Kleiman:Alas, that may be more of a problem

Kurt Pritz:Do we mean "trademarks" or "TMCH entries"?

Mary Wong:How about, "In creating your Reserved Names lists, how did you deal with trademarked terms?"

J. Scott:@Mary. I agree with your formulation.

Lori Schulman:I like Mary's approach too.

Lori Schulman:It may address Kathy's concerns.

Kathy Kleiman:nice

Kurt Pritz:I like Mary's formulation - does it take it into 'Anecdotal'?

Lori Schulman:did you check is a good question

Lori Schulman:Do the registrars run their lists against TMCH lists on the back end or do they leave it to TM owners to alert them to TM names

Kristine Dorrain:Kurt, I think brand owners care that TMs were considered, not just TMCH entries, but all.

Lori Schulman:I meant registries

J. Scott:@Kristine. I can deal with that.

Lori Schulman:I asked the wrong question

Mary Wong:@Lori, I think the registrars have to download updated domain name labels regularly from the TMCH database; I'm not sure what restrictions may govern how they use what they download (I think there are some; I will need to check the TOS for that).

Lori Schulman:ok, then maybe I did ask the right question first

Lori Schulman:thanks for clarificaton

Mary Wong:@Kristine, the staff data extraction can show who ran Start Date and who End Date sunrises. I'm not sure, but the data we already have may also show volume at various points in the cycle.

Kathy Kleiman:don't we have teh answer to that question?

Kathy Kleiman:I thought Berry has that data...

Lori Schulman:I would ask how many that they processed vs. how many registered in land rush

Lori Schulman:to see percentage

Kristine Dorrain:Kathy, I think you're right...

J. Scott:Then we may want to have Barry go through these data points and alert us to those points that we already have.

Lori Schulman:yes, that's what I mean

Lori Schulman:to see if there are meaningful correlations

Mary Wong:@J Scott, @Lori - we will check back with Berry to be sure, as he is most familiar with the data. I'm not sure we have land rush data but we ceratinly have a lot of the Sunrise data.

J. Scott:@Kristine. I agree. there should be threshold questions.

J. Scott:I think the provider may be the best to advise on the best vehicle
