1	Case Study: SSR2
Background/ Importance	Given the confusion surrounding the Board decision to suspend the SSR2 team and the subsequent hand off to the SO/AC Leaders to resolve, we believe that it would be beneficial for the community as a whole to discuss the events/processes that lead to the suspension of the SSR2 and the process engaged by the SO/AC Leaders to resolve the matter.

2	Open Data at ICANN: Developing Avenues Forward for Transparency
Background/ Importance	As ICANN moves to revamp its website and upgrade its open data offerings, it is important to consider the perspectives of both commercial and non-commercial stakeholders in determining a strategy for prioritization of its information delivery resources. ICANN's stakeholder groups have widely divergent interests and needs, and it is important to establish a robust dialogue around expectations, interests and capabilities to inform ICANN's avenue forward.
Goals/Expected Outcomes	This session aims to inform the community about ICANN's ongoing efforts to improve transparency and open data, while soliciting their feedback about current approaches and how they would like to see the system evolve.

Proposed Format	The session will begin with an introduction to open data by transparency experts, followed by a presentation by ICANN staff (possibly Duncan Burns, Mark Segall, or Jana Mila Juginovic) to bring the community up to speed on what ICANN has been doing and the road ahead. From there, the session will push into an open dialogue, where participants will be invited to comment on ICANN's initiatives, on the areas of the website they would like to see improved, or on areas of transparency that they would like to see prioritized going forward.

Background/	The top-level domains of geographic names like www.reserva.amazon or
Importance	www.watches.swiss have been the subject of much discussion on internet
	governance. When it comes to .Amazon domain, there are various topics such
	as climate change, technology and sustainability, intellectual property and
	future of the internet. There are so many interim concerns that the resolution
	processes on the future of these domain names have been studied by working
	groups, by independent reviews, and even by the board of ICANN, the
	organization that oversees domain names around the world. Before dot-
	Amazon, other trajectories were equally difficult, or even more, like in the
	cases of dot-Patagonia and dot-Africa. This session will bring content for
	discussion from the points of view of all stakeholders and most of the
	organizations involved in the definition of these geographical names. Civil
	society within ICANN that studies issues related to non-commercial domain
	names is the proponent of this workshop and will thoroughly investigate the
	commercialization of geographical names in their pros and cons. The
	participants of this session have worked on topics of technology and
	sustainability and will act as moderators inviting the participants of the event
	to bring their opinion. Through the aquarium format, where participants can
	jump in and out of the discussion, various views of this topic will be collected
	in order to formulate a coherent proposal of stakeholders for the future of this
	debate. This session is relevant as the world is taking positions in the debate
	on the future of .Amazon through its official government representatives at
	ICANN. On the other hand, the regional governments of the North and
	Northeast regions of Brazil are not yet informed of the scope of this debate.
	There is also a lack of information from the technical and scientific community
	about the nature of geographical domain names and their significance in a
	changing technological context. On the other hand, civil society has been a
	participant with information and positions on this debate. While a manifesto in
	the Bestbits community presented voices from the Amazon region and their

Goals/Expected Outcomes	The intended results are the awareness of the public, participants from neighboring countries and even those who follow Internet policy around the world, of how the geographical domain names are originated and how their use is decided. The case .Amazon will be an example of the complexity levels for the definition of use of geographical domain names and the ways to collaborate with the regulation of these internet addresses. At the time of this session, many geographical names from around the world are still being
	discussed such as in WT5 and regulated as internet domains and this vision of the future will be key to shedding light on the subject. With the collaboration of speakers from various sectors, it will be possible to create documentation of the various views on this subject that can reverse or even guide future decisions.
Proposed Format	The format will be fishbowl (aquarium), so the participants of the session will be able to make their intervention according to the agenda of the workshop, which will be explained in the beginning. The audience, then, will be invited to speak. In this format, everyone can be a speaker.

4	WHOIS Models That Could Meet the GDPR

As per ICANN's approach announced on 2 November https://www.icann.org/resources/pages/contractual-compliance-statement-2017-11-02-en this Cross Community session would enable discussion of stakeholder models developed during the intervening four months aimed at ensuring GDPR compliance while also upholding ICANN contractual obligations.
Goals/Expected Outcomes	To realize greater clarity about possible models that would achieve the dual objections of GDPR adherence and WHOIS contractual complication.
Proposed Format	Panel discussion, composed of legal experts on the EU GDPR, ICANN staff, and representatives of stakeholder groups.
