Kurt Pritz:@ Lori - I get your point but I think retaining this as an anecdotal question might save the day. The registrar might or might not have direct experience with this issue - and so we should give them the chance to indicate this knowledge if they have it.

Lori Schulman:OK.

Kristine Dorrain - Amazon Registry Services:Since my concern is really around making sure the survey provider gets it right, I think maybe i'm just suggesting two examples. (i.e. brand owners that couldn't get their brand due to reserved names list OR registrants that didn't get a name they wanted because the names was "protectively reserved" for a brand) Again, not a hill I'm going to die on.

Kristine Dorrain - Amazon Registry Services:I think it get to the point.

Kristine Dorrain - Amazon Registry Services:gets

Kristine Dorrain - Amazon Registry Services:Susan, I think that's a critical piece that we remember for registrars: technical impact. I like making sure we give them a lot of opportunities to discuss how things work technically.

Kathy Kleiman:0good let's ask it that way!

Kurt Pritz:@ Kristine: Are you saying we should leave two separate questions to give them "a lot of opportunities"? If that is your point, I am for it.

Kristine Dorrain - Amazon Registry Services:Sure Kurt, but broader than that. I think we need to consider tech impact in this entire section.

Mary Wong:Just to clarify, the Charter question as refined still referred to Registries - but as Kathy notes, for the actual survey it may be good to orient the survey question to registrars (given what the Charter question was trying to get at)

Kathy Kleiman::-) sure.

Kathy Kleiman:Good discussion. But do we want to spent 10 minutes on an overview of Registrant Questions, as Kurt requested at start of conversation?

Kristine Dorrain - Amazon Registry Services:Yes...how about did

any..?

Kristine Dorrain - Amazon Registry Services:Oh you're probably right.

Kathy Kleiman:that's fine too

Kristine Dorrain - Amazon Registry Services:Agree Kathy, I think the survey provider should make it so Q5 Qs don't show up at all if they say no.

Kristine Dorrain - Amazon Registry Services:I would hope that's a basic survey providing 101 skill. :)

Mary Wong:We can either reorganize accordingly, or add a note to this effect

Mary Wong:For the provider, I mean

Kathy Kleiman:We should be able to meet next Friday.

Kathy Kleiman:Is ICANN Staff available to host?

Kristine Dorrain - Amazon Registry Services:I suggest a note so we don't confuse anyone.

Kristine Dorrain - Amazon Registry Services:What's Friday?

Kathy Kleiman:(We have no WG meeting next week)

Kristine Dorrain - Amazon Registry Services:huh...I missed that. :) why?

Kathy Kleiman:@Kristine: Staff Policy meeting in LA next week

Kristine Dorrain - Amazon Registry Services:ahhh

Ariel Liang:All good Mary. thank you

Mary Wong:We can support a Sub Team meeting next Friday but not a WG meeting on Weds

Mary Wong:@Kurt, that can still happen even if we release a draft the week of 29 Jan. In other words, there is time to improve and finalize the document after the RFP is issued.

Kathy Kleiman:First week of February may be the best we can do.

Philip Corwin:Agree. No need to wait on final edits to put the RFP out. The sooner the better.

Mary Wong:The final bids are not due till after the initial Q&A period between ICANN and the provider, something like a month or so.

Ariel Liang:cut off time: 20:00 UTC on Monday 22 Jan

Susan Payne:understood

Mary Wong:Yes, you can not publish at all if you wish.

Mary Wong:But then it will not really give initial responders much information perhaps.

Kathy Kleiman:a few carefully worded paragraphs should be good -- sect 4, 5 and 6

Kristine Dorrain - Amazon Registry Services:Agree Kurt....

Kristine Dorrain - Amazon Registry Services:Reaching the survey respondents for sections 4 and 5 will be the toughest, I think.

Kathy Kleiman:-- sounds good -- type!

Mary Wong:@Kurt, will you be able to provide the paragraphs by

Monday?

Kathy Kleiman:@Kurt - this we can work on together over the weekend

Mary Wong:If we can get the suggested paras to the Sub Team by sometime Monday, for comments by Tuesday morning US time, we can still make it.
