Susan Kawaguchi: (08:38) Operability Accuracy – 2009 RAA Requirements The following section reviews the results of the operability accuracy tests against 2009 requirements¹³ by first looking at overall accuracy, then subgroup accuracy, followed by the reasons for error. It is important to note here that the only difference between 2013 and 2009 RAA operability requirements is that the 2009 RAA requirements do not require that information be present in the registrant email or telephone number fields, while 2013 RAA requirements do require the presence of information in these fields.
