Mary Wong: The part that Heather just read (scoping the PDP, essentially) was not changed from the original Charter.

George Kirikos: Right, bottom of page 2.

Mary Wong: @George, apologies for commenting from the staff side, but at least one (maybe more) of the options currently under consideration will likely require either modifying, or at least clarifying the UDRP. For example, if filing a lawsuit and having the IGO successfully claim jurisdictional immunity has the result of vitiating the original UDRP in the IGO's favor.

George Kirikos: "The interplay between the topic under consideration in this PDP and the forthcoming GNSO review of the UDRP, URS and other rights-protection mechanisms;" (p. 3)"

Mary Wong: First anonymous (i.e. comments not attributed to specific WG members) took place in early October. The co-chairs' proposal to use a second anonymous poll came after ICANN60.

Heather Forrest: Thanks Mary - timeline is actually helpful here

Mary Wong: The first poll was for three options (as presented to the Council and community at ICANN60). Subsequently, three additional options were raised/discussed, and the second poll was proposed to cover all the six.

Susan Kawaguchi: As GNSO liaison I monitor the PDP but have not really participated

Paul Tattersfield: exactly it's a huge abuse of process
