Paul Tattersfield:Hi Everyone

David McAuley:I am #4154

David McAuley:yes, that is the question

David McAuley:thanks Renee

David McAuley:I don't think so - maybe wrong but I thought URS was broader than TMCH

John McElwaine:Can we move on to B. The Notice? We have our one data point.

Zak Muscovitch:I think that is fine, but the URS providers can also possibly identify the nature of the mark, or we can identify it otherwise

John McElwaine:I'm fine with that.

Zak Muscovitch:I see, thanks, Barry.

John McElwaine:I dont think any data is available

Berry Cobb:A list of cases and links was provided to Kathy Klieman (sp) and she intends to find the greatest practitioners out of that data set.

Berry Cobb:We do have access to the complaints, but we don't have access to all the evidence used by an Examiner in making their final ruling.

Berry Cobb:<<sorry decision, not "ruling"

Brian Beckham - WIPO:I suggest we look to the decisions. The URS (as does the UDRP) requires that the complaint list the TM on which it is based. If the TM is not listed, then we have identified one area for improvement (that it should be always listed in the determination).

Zak Muscovitch:Yes, I agree that we can glean this info from decisions themselves.

David McAuley:Fair points by John

Brian Beckham - WIPO:To John's point, these sub-points in A (complaint) are all really one question (see my comment above).

John McElwaine:We should look at those steps to make sure that there are no flaws. I would say this ought to be referred to the practitioners group.

Brian Beckham - WIPO:Got it - thx Zak (so the RY can only look if they are on notice).

Zak Muscovitch:Yes, well put J. Scott Evans

David McAuley:well put, J. Scott - I think that is right

David McAuley:and some of what we find here may help the providers subteam

John McElwaine:I believe that there may be data in the INTA study concerning D.1.

Mary Wong:@Rebecca, we can go back to the IRT and STI reports.

Mary Wong:@Brian, that was the thinking behind the "slam dunk case" language that was used informally to describe the "clear and convincing" standard.

Berry Cobb:Time check - 15 Min

John McElwaine:@J.Scott agree

Mary Wong:@John, we may also want to look at the CCT-RT report.

John McElwaine:@Mary absolutely

John McElwaine:agree

Mary Wong:@John, did you mean filings in national courts?

Brian Beckham - WIPO:Agree J Scott - the various appeals options are too long

Zak Muscovitch:Can you repeat that J Scott?
