

## **NOTICE OF URS COMPLAINT**

MFSD is approved by the Internet Corporation for Assigned Names and Numbers (ICANN) as dispute resolution service provider for handling administrative proceedings in accordance with the Uniform Rapid Suspension System Procedure (the URS Procedure), approved by ICANN on March 1, 2013, the Uniform Rapid Suspension System Rules (the URS Rules), approved by ICANN on June 28, 2013, and MFSD's Supplemental Rules for Uniform Rapid Suspension System (the Supplemental Rules).

With the present Notice of Complaint you are hereby notified that an URS administrative proceeding has been commenced against you by the Complainant before MFSD.

You may seek legal assistance to represent you in this administrative proceeding.

A copy of the Complaint, including annexes, is sent you electronically to the following e-mail addresses: [....]

If you would like to receive the Complaint, including annexes, and other communications in the administrative proceeding to an alternate e-mail address, you are kindly requested to contact MFSD and provide such e-mail address.

The disputed domain name(s) is(are) locked by the Registry Operator(s), which is responsible for operating the top level domain in which the disputed domain name(s) is(are) registered, meaning that all changes to registration data, including transfer, modification and deletion of the domain name(s) are restricted, but the domain name(s) continue(s) to resolve.

A Response to the Complaint may be submitted by you within 14 calendar days from the date of receipt of the present Notice of Complaint. The Response may be submitted in English or in one of the languages used for the present Notice of Complaint. The Examiner will determine, in its sole discretion, in which language to issue its Determination.

The link for online submission of your Response in English is the following: https://urs.mfsd.it You should register on the platform in order to have access to the Response form.

If you submit your Response in [....] (a model form is hereto attached), it should be sent to us to the e-mail address: <u>urs@mfsd.it</u>

Upon your request a limited extension of time (maximum 7 calendar days) to respond may be granted by MFSD if there is a good faith basis for doing so and if such request is received during

the 14 calendar day Response period mentioned above, after the expiration of such period, or not more than 30 calendar days after the Determination of the Examiner.

The Response period may also be extended by written stipulation between the Complainant and you, provided the stipulation is approved by MFSD.

If at the expiration of the 14 calendar days Response period (or extended period if granted) you does not submit a Response, the Complaint will proceed to a Default Determination.

There will be no discovery or hearing in the present administrative proceedings; the evidence will be the materials submitted by the Parties with the Complaint and the Response, and those materials will serve as the entire record used by the Examiner to make a Determination.

If the Examiner rules in favor of the Complainant, the Registry Operator will suspend the disputed domain name(s) for the balance of the registration period (extendable to 1 year by the Complainant for fee) and it(they) will not resolve to the original web site, but redirect to MFSD's informational web page about the URS. The Whois for the domain name shall continue to display all of your information except for the redirection of the nameservers and reflect that the domain name(s) will not be able to be transferred, deleted or modifies for the life of the registration.

If the Examiner rules in your favor, the Registry Operator will unlock the domain name(s) and return full control of the domain name(s) registration to you.

If appropriate and the allegation can be substantiated with evidence, you may request to the Examiner to make a finding that the Complaint is abusive.

You shall pay a Response Fee set forth in the Supplemental Rules if Complaint lists fifteen 15 or more disputed domain names registered by you. Such Response Fee will be refundable to the prevailing party.

For Responses filed more than 30 calendar Days after Default Determination, regardless of the number of domain names in the Complaint, you shall pay a Re-examination Fee set forth in the Supplemental Rules.

Fees are payable together with the respective submission by credit card via secure online payment facility. If required fee is not paid, the Response will not be considered submitted and the dispute may proceed as a Default.

By submitting a Response to MFSD you agree to abide and be bound by the provisions of the URS Procedure, URS Rules and the Supplemental Rules.

By submitting a Response you also authorize the treatment of your personal data pursuant the Regulation (EU) 2016/679 (General Data Protection Regulation - GDPR) and according to MFSD's Privacy Policy published at https://urs.mfsd.it/privacy-policy
