Vlad Dinculescu:Having both would be beneficial. The more options the better

Leana Melnichuk:I agree the more options the better

Margie Milam:Agree with Steve

Sara Bockey:Just a note/comment....this is a complicated list and will require manual review and entry by someone, or multiple people, in order to collect. In that, there may be human error.

Vlad Dinculescu:Agree with Sara, and further to it, the more fields we allow, the more difficult it will be to generate the report

Sara Bockey:Yes, agree Vlad. That is why it needs to be simplified as much as possible

Sara Bockey:The more simple the better the data ... so if IP can drill down on specifics / what's most important that would be great

Amy Bivins:Rr proposal: Where a disclosure request has been categorized as High Priority, LEA will make every effort to contact the Provider directly to discuss the matter, and should it be determined that Provider has useful information, Provider shall use its best efforts to action the request within one business day, noting that a court order/subpoena may still be required prior to release of any information. Registrar will not be required to take any action in contravention of applicable law.

Sara Bockey:I don't think I have anything additional to add

Lindsay Hamilton-Reid:I was just about to type that.

Lindsay Hamilton-Reid:Thanks Amy.

Sara Bockey:and I'm still concerned thta Section 4.2.2 doesn't recognize extraordinary circumstances that could arise outside of the 3 reasons list.

Lindsay Hamilton-Reid:Agreed Sara.

Mary Wong:Will PSWG members be at the IRT meeting in ICANN61?

Peter Roman:I have a question, isn't this the method for contacting the provider directly?

Sara Bockey:Pick up the phone

Sara Bockey:I don't understand that you are saying Amy....So I'm envisioning a call to the provider or affiliated registrar

Sara Bockey:And it cannot be published. It would need to be provided via a RADAR database or other means not public

Sara Bockey:The Final Report doesn't say anything about publishing
