#### Meeting Notes

1. **Review of reference documents.** The members discussed review of some relevant documents. Based on the discussions, the following initial list of documents was developed:
  - a. RFCs covering IDNs
  - b. GNSO policies and reports for IDNs
    - i. AGB
    - ii. GNSO new gTLD guidelines – IDNs work group report
  - c. ccNSO policies and reports for IDNs

    - i. Variant Issues Report
    - ii. LGR Procedure
    - iii. User Experience

2. **Stability, consistency and scope of IDN Guidelines.** The members discussed developing guidelines in a way that they remain stable (to the extent possible) over time until they are revised. Further, the recommendations should be systematic so that they provide a consistent user experience across TLDs. Guidelines should be general, covering all the TLDs, including ccTLDs and gTLDs, and not specific to a particular subset. The guidelines may be applicable to multiple levels and may be binding vs. non-binding.
  
3. **Discussion on specific issues for the Guidelines.** The members discussed some specific items contributed by the members through emails. These included implementation of some aspects IDNA 2008 standard but which are sometimes not adhered to in practice, e.g. as informed by the Pre-Delegation Testing. The group discussed to make a comprehensive list at this time and not prioritize the items at this time. Some points identified included the following:
  - a. Implementation issues related to IDNA 2008
  - b. Use of Hyphen
  - c. Script Mixing
  - d. Script tags

4. **Regular meeting times.** The group will continue to meet on Wednesdays at the same time, fortnightly. Those who did not attend to share any objection with staff, in case this time is not convenient, for reconsideration of time.
