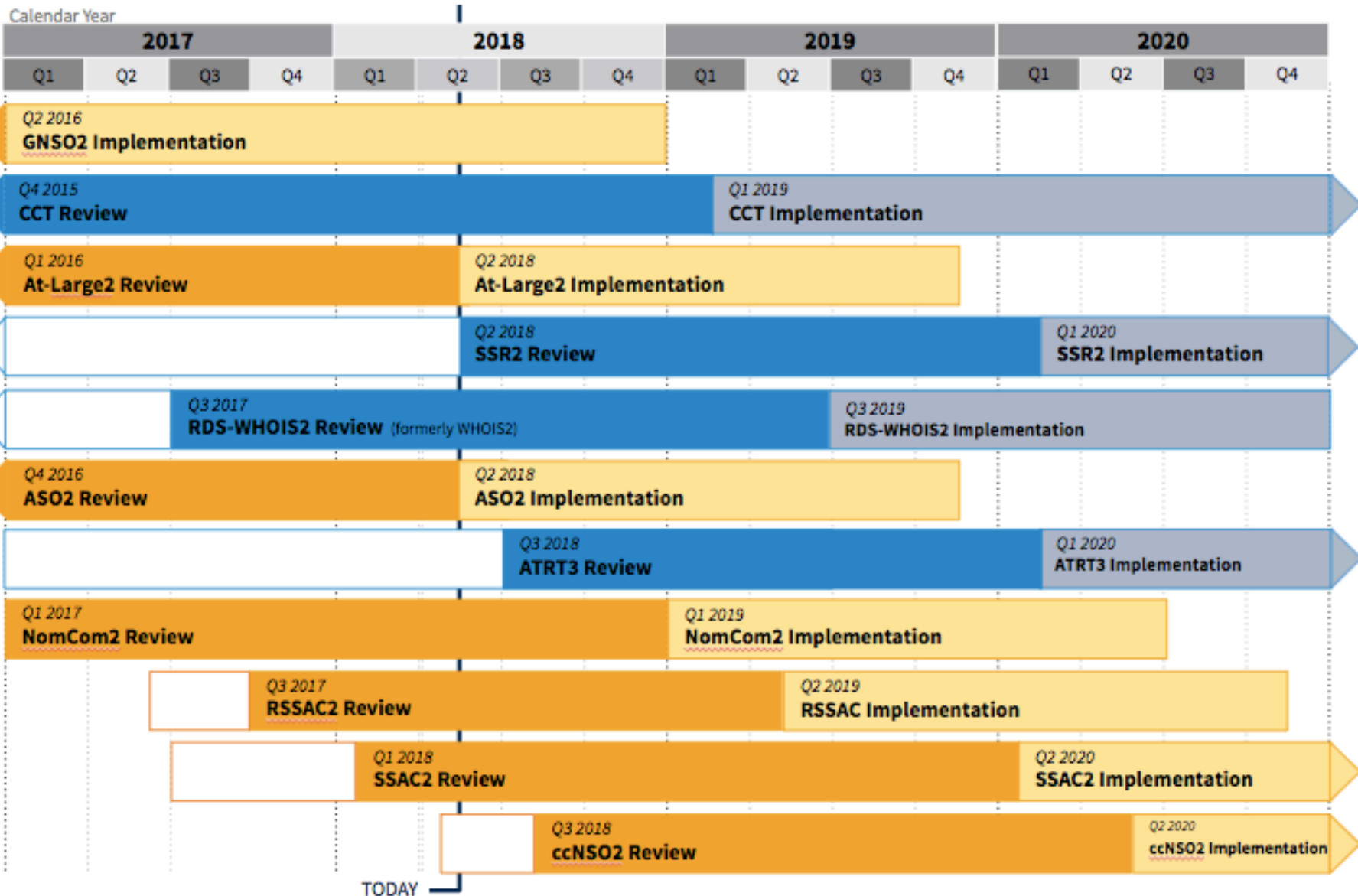

# Why are We Addressing this Issue Now?

- 1** Large number of reviews currently underway - 11 reviews in various phases of work.
- 2** Significant other work impacting the ICANN community (e.g. GDPR, new gTLD PDP, WS2 and WS2 implementation).
- 3** Requests by the community to look for options to lessen the strain that the Review Timeline is placing on community and ICANN org resources.

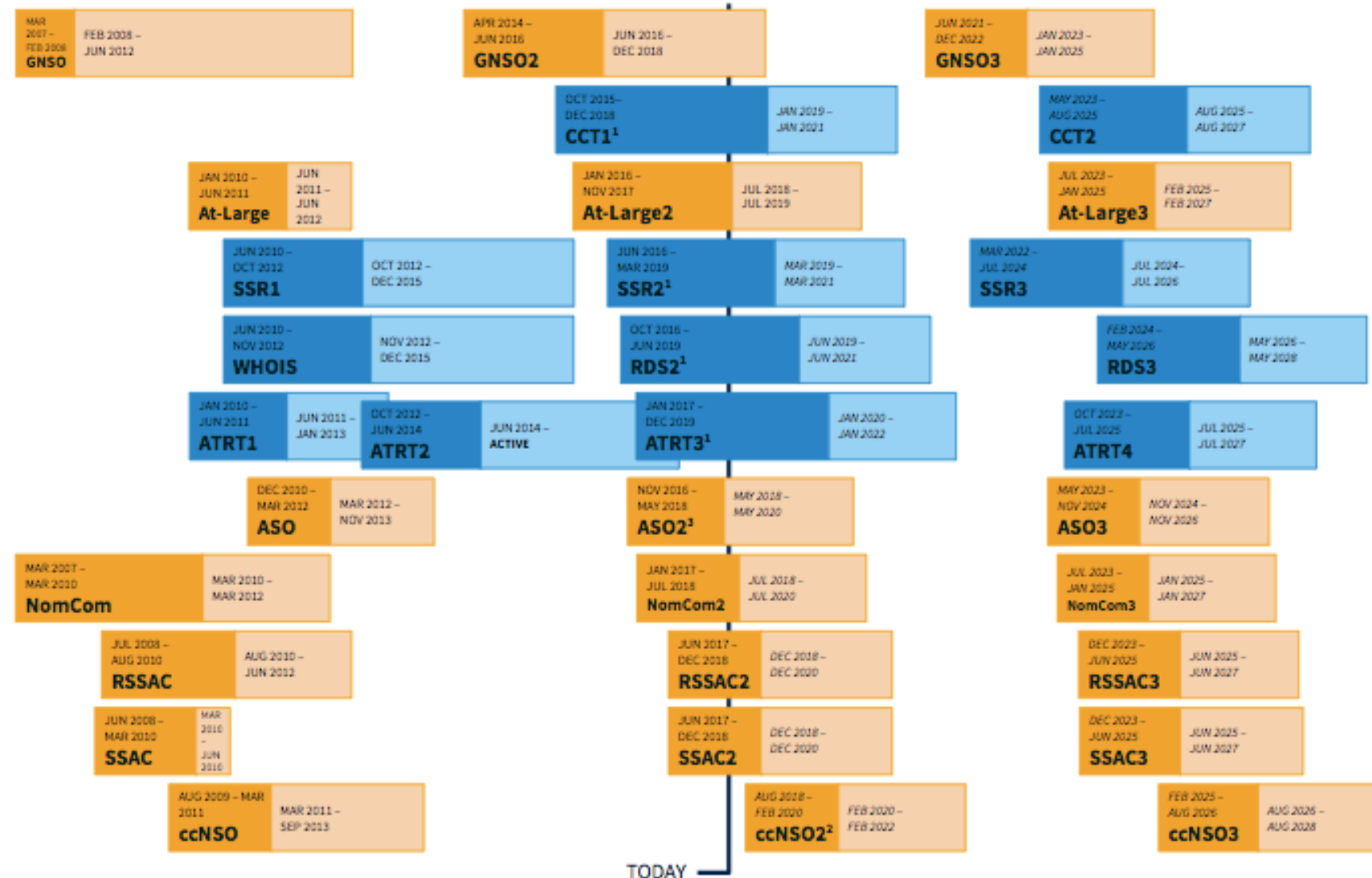

# Resource to Support ICANN Reviews

## Specific Reviews

*led by teams comprised of  
community members*

**Volunteers:** up to 21 members

**Funding:** ~\$500,000-\$700,000 USD

**Time:** 42 – 60 months total:

- 6-12 months to plan
- 12-24 months to execute
- 6 months board analysis/action
- 18+ months to implement

## Organizational Reviews

*led by Independent Examiners with  
support from community Review  
Working Parties*

**Volunteers:** 12 to 20 Review  
Working Party participants

**Funding:** ~\$250,000 USD

**Time:** 42 months total:

- 6 months to plan
- 12 months to execute
- 6 months board  
analysis/action
- 18 months to implement

# Proposals Posted for Public Comment

**1** **Short-Term Options:** pertaining to ATRT3 to address the workload of the volunteer community and impact on ICANN resources – with options ranging from staying the current course, to limiting the scope and deferring the review. Link: <https://www.icann.org/news/announcement-2-2018-05-14-en>

**2** **Long-Term Options:** provide more reasonable scheduling options across ICANN reviews (Specific and Organizational), with the goal of meeting ICANN's accountability and transparency obligations in a more practical and sustainable manner. # Short-term Options

## SHORT-TERM OPTIONS\*

### Review | Option

**ATRT3 | A “No change”** Begin as soon as feasible<sup>[1]</sup> (estimate: July 2018).

**ATRT3 | B “Limit Review to Implementation of Prior Recommendations”**  
Begin as soon as feasible (estimate: July 2018).

**ATRT3 | C “Commence RT work upon Board action on CCWG-WS2 recommendations”**

(with the work of the Review Team to start no later than 30 June 2019 and conclude within twelve months, as prescribed in the Bylaws)

\*RDS-WHOIS2 options have been removed by request of the RDS-WHOIS2 Review Team

## PRINCIPLES

Principles to inform these approaches:

- to aim for no more than three to four reviews per year,
- recognize limited community resources,
- ensure adequate funding for reviews, and
- ensure efficiency and effectiveness of the reviews.



# Long-term Options

## LONG-TERM OPTIONS

**Staggering the reviews** to have no more than one Specific Review and two Organizational Reviews running concurrently.

**Adding timing criteria** in order to initiate the next cycle of a Specific or Organizational Reviews, which could include factors such as a requirement that prior review recommendations be fully implemented and possibly operational for a period of time before the next review is initiated.

**Adding requirements** that, like the ATRT, other Specific Review teams complete their work within 12 months. This requirement could also be applicable to Organizational Reviews (although because Organizational Reviews are conducted by independent examiners based on contractual agreements, timing considerations are already incorporated into the process),

**Focusing Work** of Specific Review teams' on topics of highest priority to the community.

**Adding scheduling flexibility** for Specific Reviews to the Bylaws, with appropriate checks and balances.
