Lisa Phifer: (10:29) @Lili, are you asking for the P/P report to note this as an issue or a recommendation? Susan Kawaguchi: (10:29) P/P customer data is to be validated and verified in a manner consistent with the requirements outlined in the WHOIS Accuracy Program Specification of the 2013 RAA (as may be updated from time to time). In the cases where a P/P service provider is Affiliated with a registrar and that Affiliated registrar has carried out validation and verification of the P/P customer data, re- verification by the P/P service provider of the same, identical, information should not be required.

Lili SUN 2: (10:30) @Lisa: i mean the data accuracy behind P/P service should be dealt by this subgroup.

Lisa Phifer: (10:31) @Lili, could you propose text or identify subsections where you believe this needs to be addressed?

Lili SUN 2: (10:31) @Lisa: the findings of Data Accuracy of P/P service is unkonw.

Stephanie Perrin: (10:31) I think it is something that is going to be challenged, as soon as it comes out the other end.

Susan Kawaguchi: (10:32) @Lili I copied in the language from the PPSAI report

Stephanie Perrin: (10:32) indeed Alan, I believe you have put your finger on the problem

Susan Kawaguchi: (10:32) the PP provider has the same responsibility on accuracy as the registrar's do for regular registration

Cathrin Bauer-Bulst: (10:35) leaving adobe but still on the phone

Carlton Samuels: (10:36) @The argument as to whether agency rules apply for the P/P provider is really

pointless. SOP says the agent has the same obligations as the registrant!

Lisa Phifer: (10:39) It sounds like a compliance issue that the contract requirements are not monitored and thus cannot be enforced?

Erika Mann: (10:43) ... only in a criminal case privacy proxy procedures could be lifted (though not always possible) ...

Erika Mann: (10:44) @Volker - correct -m

Carlton Samuels: (10:44) Its the reason the provider has to be put thru the AML /KYC type registration process.

Stephanie Perrin: (10:44) It is indeed rather unfortunate that we failed to distinguish in the oolicy

Stephanie Perrin: (10:44) that was policy. Privacy v proxy

Lisa Phifer: (10:46) @Susan, it seems like this should be an option when filing an innacuracy report that the inaccuracy is in data supplied by a P/P, not in data published in WHOIS
