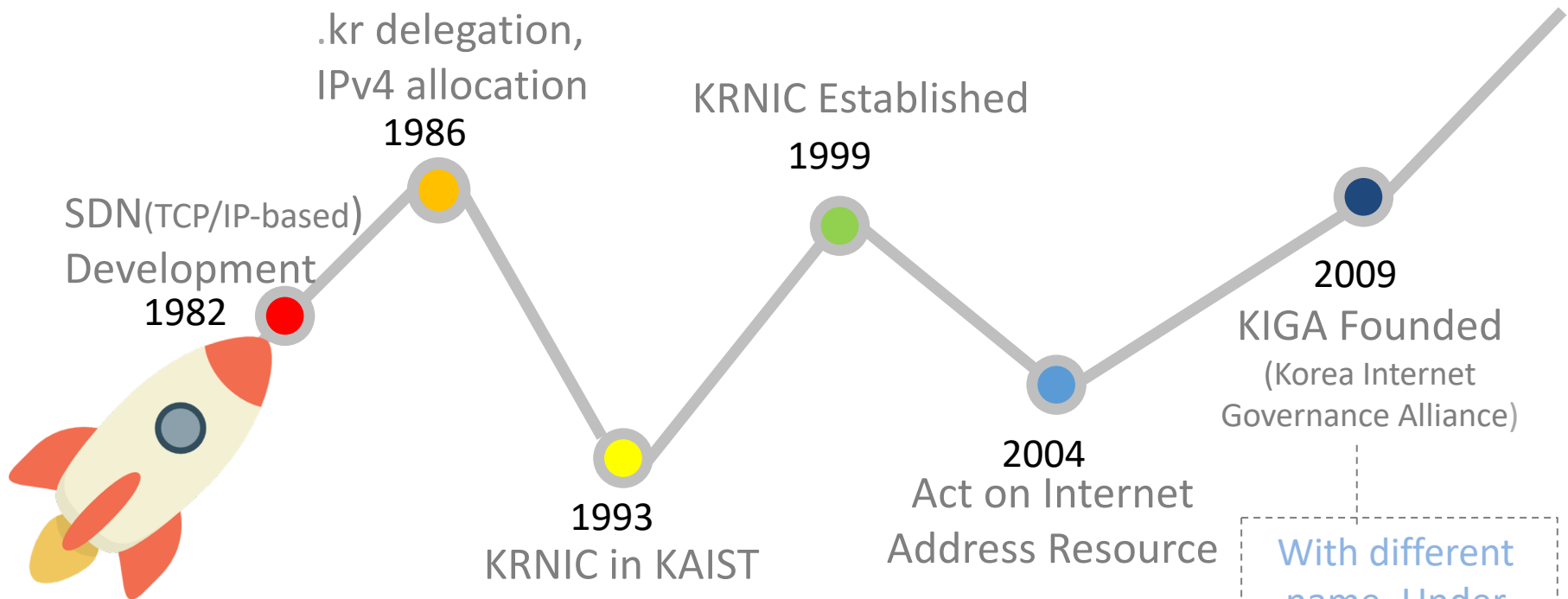

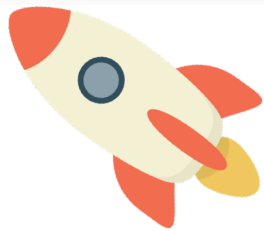

3. Role of Each Stakeholder

Final decision maker on making policies for Internet address resources, etc.

- o The State shall endeavor to promote the development and use of Internet address resources and ensure that Internet addresses are used in a fair and appropriate manner
- o The state shall endeavor to ensure that policies related to Internet address resources are formulated and implemented in a transparent and democratic manner



3. Role of Each Stakeholder

The Internet Address Policy **Deliberation** Committee

Deliberation Committee shall deliberate on the following matters :

- o Formulation and implementation of basic plans
- o Approval for the entrustment of duties of Internet address management organizations
- o Approval for the standing rules on the management of Internet addresses
- o Major policies for the settlement of disputes related to Internet addresses
- o International cooperation related to Internet address resources
- o Other policy matters related to Internet address resources, submitted by the Chair



3. Role of Each Stakeholder



Under Article 52 of the Act on Promotion of Information and Communications Network Utilization and Information Protection, etc.,

KISA performs duties related to the assignment and registration, etc. of Internet addresses and any corporation or organization entrusted with duties of managing Internet addresses by the Internet and Security Agency

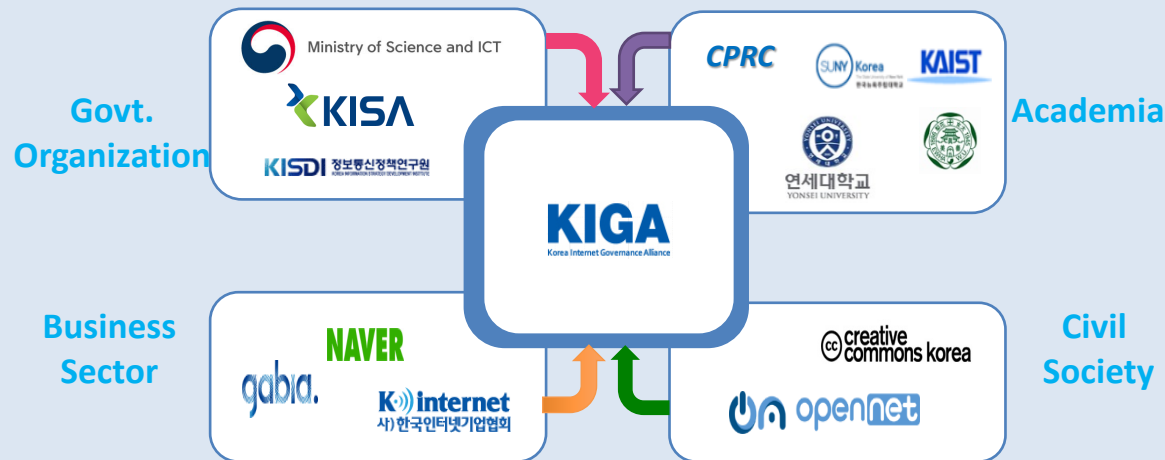

Anyone who is interested in Internet address resources can submit their own idea to be dealt with by the Internet address policy deliberation committee.

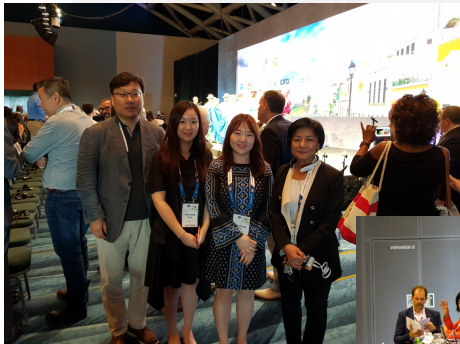
If those ideas are concrete enough to be dealt in the deliberation committee, ideas from multistakeholder can be heard by policy makers.

Also, the deliberation committee is open to anyone who is interested in Internet address resources. They can apply to attend the deliberation committee meeting to see how policies are made and they can also make a speech under some circumstances.
