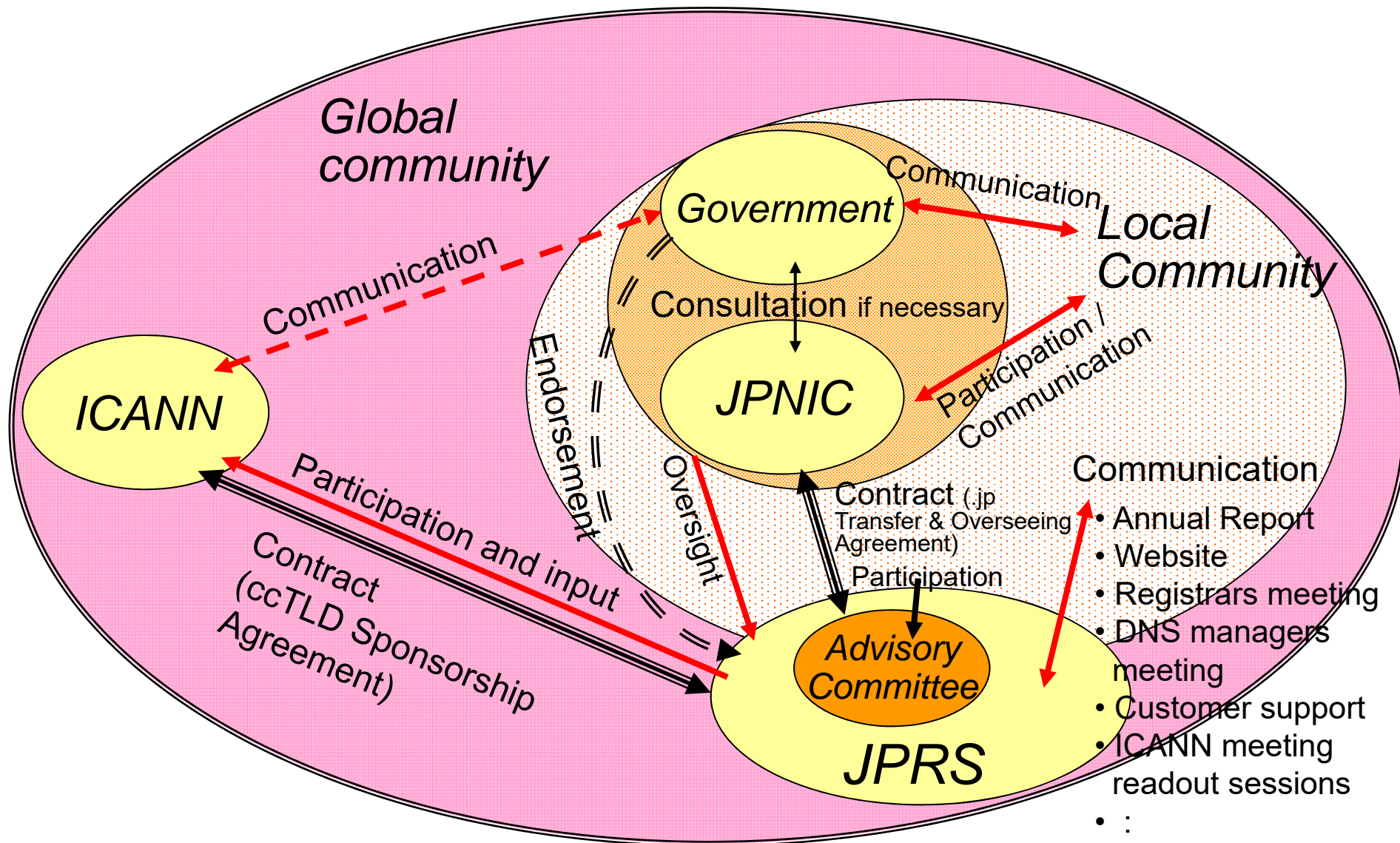

ccTLD (.JP)	<ul style="list-style-type: none"> <li>• Manages <u>.JP domain names</u> <ul style="list-style-type: none"> <li>- Develops name registration policy and registry systems</li> <li>- Manages registry database</li> <li>- Operates JP Domain Name System</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>• Oversees management of .JP ccTLD conducted by JPRS (through consultation with gov.)</li> <li>• Finds new registry operator in case redelegation from JPRS is necessary (thru consultation with gov.)</li> <li>• Maintains JP-DRP (JP domain name dispute resolution policy)</li> </ul>

# Running .JP for the interest of the community

- “Advisory Committee” on JP domain name service policy
  - members are the representatives from the following 7 sectors
    - JPNIC
    - JP domain name registrars
    - ISPs
    - Private sector (user companies)
    - academic experts
    - individual Internet users (e.g., consumers)
    - Japanese Government (from 2015)
  - JPRS submits an inquiry when it is necessary or Advisory Committee spontaneously finds it necessary to discuss from the aspect of fairness and neutrality in managing .JP services.
- Check on stability as an registry
  - JPRS reports its service performance and financial status to JPNIC and the government at least once a year. And then, JPNIC and the government check it.
  - JPRS reports its financial status to the public.

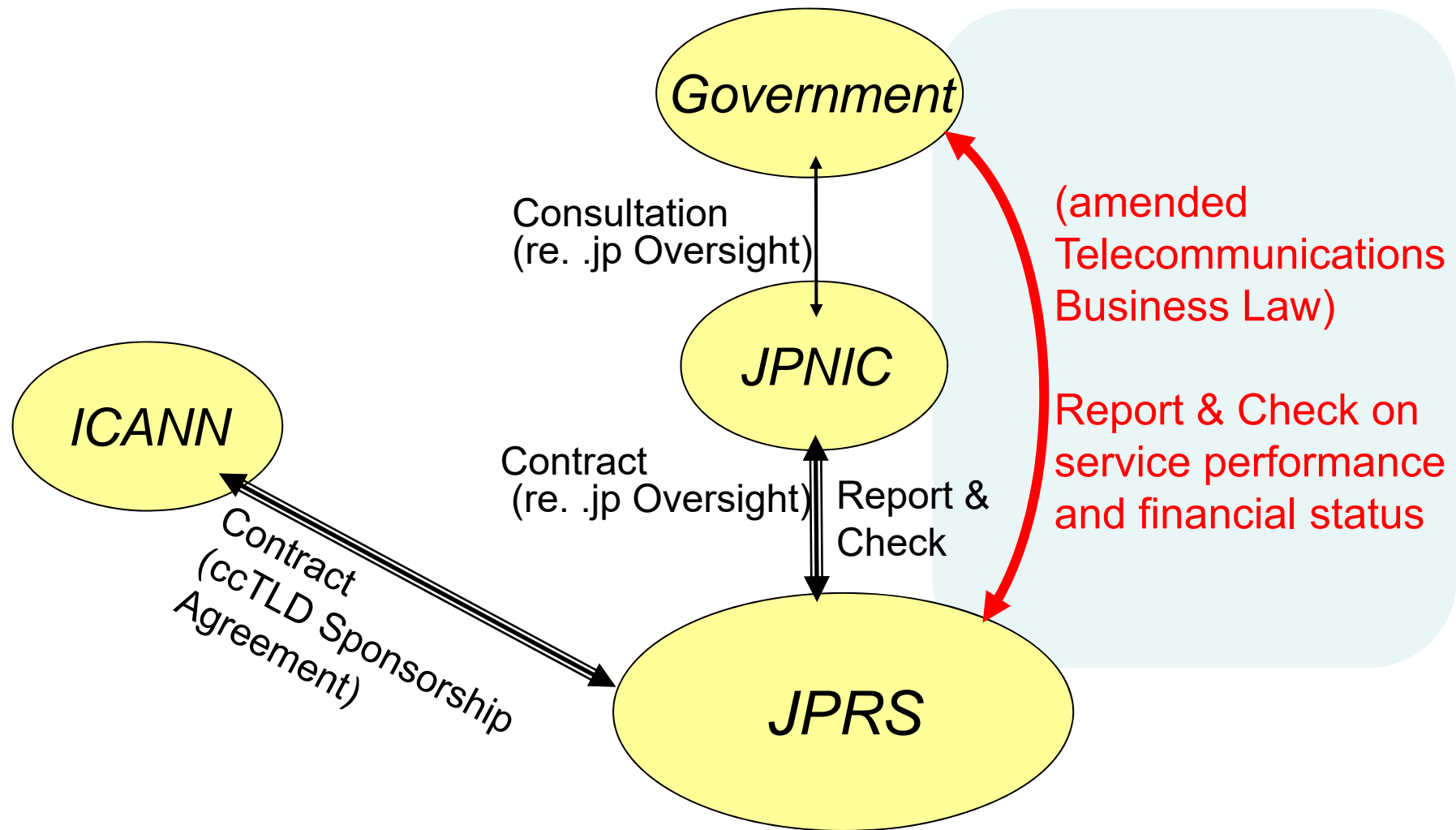

# Japan IGF

- “Japan IGF” is the collective name of two activities regarding Internet Governance in Japan
- Registered as “National and Regional IGF initiatives (NRI)” in Nov 2016

## Japan IGF

### IGF Japan

- Annual meetings
- Main contents
  - + report session of global IGF
  - + sharing information and discussion on main topics in each IGF

### IGCJ

(Internet Governance Conference Japan)

- A platform to advance Internet Governance in Japan
  - + dedicated mailing list
  - + bi-monthly meeting
- Main contents
  - + sharing information and discussing mainly on proposed themes from participants.

# Why IGCJ?

- Internet Issues are getting more...
  - complicated, globalized, seriously impacting, stakeholders involved, politicized, ...
- Low interest/concern about Internet Governance in Japan
  - Less awareness regarding importance of IG discussion
  - There hadn't been any suitable activities in Japan to address this situation (as of 3 years ago)
- IGCJ aims to be a (bottom-up) platform
  - for various stakeholders
  - to discuss various Internet-related issues
  - no decision making mechanism in IGCJ
- IGCJ keeps its activities continuous
  - Physical meetings with remote participation every other months
  - Provide information through Mailing list, facebook page, etc
- IGCJ liaises with other existing/theme-specific activities
