Jean-Baptiste Deroulez: (10:26) comment from Stephanie on screen: Doubtless I brought this up before and was rejected....but here is a hint for the CEO and Board: when the data protection

authorities, particularly the Chair of the Article 29 Working party, and the European Data Protection Supervisor write to you repeatedly telling you you are breaking the law, pay attention. Reply. NCSG held a workshop on data protection with participation from the DPAs in June 2014 in London, same time as I dissented from the EWG report.

Volker Greimann: (10:31) " especially as regards to addressing impacts of data protection laws in a forward-looking manner""

Jean-Baptiste Deroulez: (10:34) comment from Stephanie on priority: The previous recommendation is a higher priority, but as it serves to create overall accountability and transparency of the Board's activities in a key field, it is nonetheless of strategic importance.

Jean-Baptiste Deroulez: (10:35) We are on page 29: Rec. 1.3

Lisa Phifer: (10:35) Can the RT agree to "medium"

Erika Mann: (10:36) Yes

Carlton Samuels: (10:37) Yes to medium

Carlton Samuels: (10:40) Acceptable

Jean-Baptiste Deroulez: (10:40) comment from stephanie on p34: I object to this section. Firstly, it is very unclear. What does "insofar as the EWG's final report recommendations are actioned..." mean? The report never achieved consensus. What is green field RDS policy making? When did the team decide that had the plan seen execution to the end, the single policy would have emerged? I doubt it, given all the other bifurcated policies being implemented on separate time frames. Further, "the Expedited PDP that conforms to byelaw and raised to anchor that specification as consensus policy will suffice and produce the single RDS (WHOIS) policy as anticipated." is factually inaccurate, this is not what the EPDP is doing. This section needs a rewrite.

Lisa Phifer: (10:43) Note the paragraph refers to the question addressed by the review team, with the finding that follows. Possibly what is requested here is an addition to the finding?

Jean-Baptiste Deroulez: (10:47) SP16: The temp spec may be affirmed, it may be changed, or it may be thrown out, Whereupon we will have nothing. I find this assumption to be in denial of the facts. Object strongly.

Erika Mann: (10:48) I would drop it as well

Erika Mann: (10:48) Not totally correct. The EPDP is only a must for European personal data Erika Mann: (10:49) Stephanie it doesn't work with Google Chrome

Jean-Baptiste Deroulez: (10:50) SP17: The EWG report was accepted by the Board. I have no idea what the official status of my dissent was, it was described by staff and the contractor who managed the EWG as a "blog" for some time. However, referring to it as "adopted" seems to imply it now has some kind of policy status, which it does not. Valuable research, but that is where it ends.

Volker Greimann: (10:51) Erika, also not totally correct ;-) It is also for worldwide data processed by European processors

Erika Mann: (10:52) Similar to what I said Volker.

Erika Mann: (10:54) Volker - actually I believe European porocessors could, and often must if they operate on a global scale - in principle - differentiate between European and third party personal data. Pretty sure SWIFT must do this (as an example).

Volker Greimann: (10:55) GDPR forces us to treat all data equally. GDPR applies to all data we process as European processors.

Volker Greimann: (10:55) personal data, of course

Jean-Baptiste Deroulez: (10:57) We are now on rec. 36 (rec #3)

Jean-Baptiste Deroulez: (10:57) reviewing comment SP19 from Stephanie: I realize we say this for every section, but are we dead certain that every member reviewed every document? iF not, lets delete the word ALL....

Lisa Phifer: (10:58) The board adopted the motion but accepted the report

Erika Mann: (10:59) Not sure if that is fully correct Volker but I would have to read the text again. If a European operator is managing personal data from China, then the operator will have to respond to European but to Chinese law as well ... depending on the specific accase /feature of

personal data. In the financial service environment - for example - the treatment of personal data must follow different laws - including international ones. But, I agree, it's a tricky area.

Lisa Phifer: (10:59) "Resolved (2015.04.26.10), the Board reaffirms its request for a Board-initiated GNSO policy development process to define the purpose of collecting, maintaining and providing access to gTLD registration data, and consider safeguards for protecting data, using the recommendations in the Final Report [PDF, 5.12 MB] as an input to, and, if appropriate, as the foundation for a new gTLD policy;Resolved (2015.04.26.11), the Board directs that a new Preliminary Issue Report that follows this framework [PDF, 612 KB] be prepared and delivered to the GNSO"
