SSR1 Implementation Gap Analysis

⦿ **Scope of work:**

- Analysis of how ICANN implemented SSR1 recommendations, identifying gaps between intent of recommendations and actual implementation.
- Analysis and conclusions to be documented in a written report.
- Review materials (i.e. SSR1 Final Report, Implementation updates, Implementation Briefings, etc.) and work in coordination with Review Team to develop work plan and methodology.

⦿ **Required Skills, Expertise and Qualifications:**

- Knowledge of structure, operations and relationships between ICANN and its communities.
- Understanding of ICANN's Bylaws and its role to ensure the stable and secure operation of the Internet's unique identifier systems that fall within this remit.
- Extensive knowledge of the DNS – both protocol development and ICANN's role regarding SSR.
- Extensive technical background and understanding of Internet security, resiliency of the Internet and all associated terminology.
- Technical writing experience.
- Ability to work cross-functionally to obtain information and facilitate discussions.
