## a. Status of public comments received

Alan Greenberg shared concerns that Contractual Compliance is already doing what the review team is recommending and invited the review team to be more proactive on identifying that.

Alan Greenberg suggested to go through the report in Brussels and identify sections that needs to be tightened considering the report has too many pages and goes too much into details.
