






ccTLDs and DNS Abuse

About the DASC survey

From September to November 2022, the DASC conducted a survey to better understand the ccTLD DNS abuse landscape and explore ways to assist ccTLDs in their efforts to mitigate DNS abuse.

The survey results reflect the diversity of ccTLDs different regions, with different registration and governance models, including both larger smaller TLDs. Most respondents reported less than 0.1% of their names under management being affected by DNS Abuse. The survey results furthermore revealed that even ccTLDs with limited resources. including funding and staff, can effectively mitigate DNS abuse.

At ICANN78, the ccNSO Internet Governance Liaison Committee (IGLC) organises a session which explores the United Nations (UN) led review of the World Summit on the Information Society (WSIS) being held in 2025 on the twentieth anniversary of the original WSIS, and explains why it matters to ccTLDs around the world.

The main purpose of the session is to inform interested community members about different perspectives on tools and measurements of DNS Abuse.
