## Nominations for ICANN Board Seat 12 open now

The term of Katrina Sataki, the ccNSO nominated Director fulfilling ICANN Board Seat 12, will expire at the ICANN81 Annual General Meeting held in October 2024. By October 2024, Katrina will have served one term on the Board: she is eligible for reappointment. Directors to the ICANN Board may maximum three consecutive serve terms.

The ccNSO Council is required to select a candidate in accordance with the relevant ICANN Bylaws and internal rules of the ccNSO applicable at the time of the call for nominations. The call for nominations is currently open and closes on Wednesday, 9 August 2023 (23:59 UTC). Elections will be held in November 2023, after completion of diligence verifications by a professional firm on the nominee(s). A Q&A session with candidate(s) will be held at ICANN78.

- 5. Stop recording
- 6. End meeting

- The <u>ICANN78</u> Annual General Meeting runs from 21-26 October in Hamburg, Germany. Prep Week will be held online only, 9-11 October 2023.
- The comprehensive schedule will be published on 2 October 2023. The Prep Week schedule will be published on 25 September 2023.

#### Saturday, 21 October & Sunday, 22 October

Various ccNSO Working Groups and Committees will hold working sessions, including the Guidelines Review Committee (GRC), The Strategic and Operational Planning Committee (SOPC), the DNS Abuse Standing Committee (DASC), the ccNSO Council, the Internet Governance Liaison Committee (IGLC), the TLD-OPS Standing Committee as well as Tech Working Group.



#### Monday, 23 October

ICANN78 will start with the Opening Ceremony. Other

sessions on the agenda include an ICANN 25-year Anniversary Session and a Q&A session with ICANN Org executives. Also, Monday is traditionally Tech Day.

## ccNSO Council Highlights



The ccNSO Council had its 197th meeting on Thursday, 20 July 2023. Topics for discussion included:

- an overview of some intermeeting decisions, including the appointment of additional members to DASC and IGLC, the approval of the <u>NomCom rebalancing</u> <u>submission</u> and the <u>submission regarding the PTI Bylaws change</u>.
- appointments of 3 additional members to the TLD-OPS Standing Committee
- adoption of the ccNSO Guideline on ccNSO Statement of Interest and Conflict of Interest procedures
- adoption of the Terms of Reference of the new ccNSO Working Group on Universal Acceptance, and the decision to launch a call for volunteers for the new ccNSO UA Committee.
- kick-off of the effectiveness review of the ccNSO Outreach and Involvement Standing Committee (OISC)
- a discussion regarding a <u>letter</u> by Kim Davies, President PTI to Council, regarding the caretaker designation for ccTLDs in the Root Zone.
- the approval of the ccNSO membership application by the .qa (Qatar) ccTLD manager
- an introduction to the proposed GRC guideline on Implementation.
