During the ICANN76 ccNSO Governance Session the ccNSO Guidelines Review Committee (GRC) will seek ccTLD community input on the proposed ccNSO statement of interest (SOI) and ccNSO Council conflict of interest (COI) processes. A subcommittee of the GRC developed the proposals, based on

previous consultations. The most recent consultation took place at ICANN75.

In addition to the SOI/COI discussions, the committee chair Sean Copeland (.vi) will have a fireside chat with Marika Konings (VP, Policy Development Support) and Karen Lentz (VP, Policy Research and Stakeholder Programs) about the ccNSO role with respect to the implementation of policies developed through a ccNSO Policy Development Process. Understanding the ccTLD DNS Abuse landscape

The DASC recently launched a survey to understand the ccTLD landscape with respect to handling the various aspects of DNS Abuse. After analysis of the results, the DASC is now ready to share the main survey findings with the ccTLD community. The DASC also presents its repository, an online information source about DNS Abuse, for the benefit of ccTLDs.

About DASC

The DNS Abuse Standing Committee (DASC) is the core of the ccTLD community-driven process around DNS abuse. The DASC was created as a dedicated forum for ccTLD managers to discuss the important topic of DNS abuse and share information, insights, and practices. In keeping with the nature of the ccNSO, the purpose of the DASC is not to formulate any policy or standards. Instead, its overarching goal is to increase understanding and awareness of the issues pertaining to DNS abuse, promote open and constructive dialogue, and ultimately assist ccTLD managers in their efforts to mitigate the impact of DNS abuse.

If approved, the recommendation will be put forth to the ccNSO members to vote on. Voting will start Tuesday, 18 April 2023 and will end Tuesday, 9 May.
