Preparing for a virtual ICANN68 Policy Forum

Join the special ccNSO Council meeting

Due to the quickly developing effects of the COVID-19 pandemic, it is highly probable that ICANN68 – scheduled to be held in June in Kuala Lumpur – will be held virtually. To adequately **prepare for a potential Virtual ICANN68 Policy Forum**, the ccNSO

Council and the ccNSO Working Group and Committee Chairs will meet, to discuss the impact and way forward for the ccNSO schedule.

Topics on the agenda will include, among others:

- Lessons learned from the virtual ICANN67 Community Forum
- Which meetings need to be held as part of the ICANN68 schedule? Based on which criteria?
- Which meetings should be held, but not necessarily as part of ICANN68? For instance, are there any sessions that should be held as webinars instead?
- Which meetings can or should be deferred until the next time we meet in person?
- How – if any – should the ccNSO contribution to ICANN68 plenary sessions look like?

The annual term of the current ccNSO Chair and Vice-Chairs concluded at the end of ICANN67. During the March ccNSO Council meeting, the ccNSO Council appointed Katrina Sataki (.lv) as Chair of the ccNSO and Alejandra Reynoso (.gt) and Pablo Rodriguez (.pr) as Vice-Chairs. They were all appointed for a one-year term, starting at the end of ICANN67 and ending at the end of ICANN70.

The ccNSO Council wishes to thank Byron Holland for his commitment and service as Vice Chair, since 2016. Additionally, a long-standing community member left the Council – Hiro Hotta, .jp. His seat on the Council was taken by Ai-Chin Lu, .tw. The ccNSO Council welcomes Ai-Chin and wishes to wholeheartedly thank Hiro for his continued and dedicated service to the ccNSO Council.

ccPDP3: what is the current status?

This third-ever ccNSO Policy Development Process aims to develop policy recommendations for the ICANN Board, which will include a review mechanism pertaining to decision on the delegation, transfer, revocation, and retirement of ccTLDs.

In March 2017, the Council decided at the time to split the work in 2 phases:

- Phase 1 (ccPDP3-ret)

This group is about to publish its Interim Report for public comments. The working group focused on the retirement of the delegated Top Level Domains associated with alpha-2 codes assigned to countries and territories listed in the ISO 3166-1 standard. Read more [here](#).

- Phase 2 (ccPDP3-rm)

Here, the focus lies on the review mechanisms pertaining to decisions regarding the delegation, transfer, revocation and retirement of ccTLDs. The ccNSO council recently appointed members on the Working Group. As per the groups' charter, participants from other SO/ACs and experts from ICANN org staff and PTI have been invited to join the group as well. To inform interested parties about the work of this Working Group, the ccNSO Secretariat hosted a series of webinars, targeted at ccTLD Managers, ALAC and GAC members. You will be able to find the recordings [here](#). The webinars have proven to be an effective way to involve other SO/ACs in the work of ccPDP3-rm.

The group had its inaugural meeting on 25 March. Moving forward, topics on the group's agenda include:

- Nomination of a Working Group Chair and Vice-Chair, who will then be appointed by the ccNSO Council.
- Discussion on the "Rules of Engagement". These rules are intended to guide the internal working methods of the group.
- Review of the charter and agreement on high-level working plan.

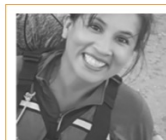
The ccNSO Secretariat, as part of ICANN's Policy Development Support Team, provides logistical and substantive support to the ccTLD Community.



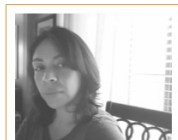
