The ccNSO meets at ICANN68

The Country Code Names Supporting Organization (ccNSO) program begins on Monday, 22 June 2020 with <u>Tech Day</u>, a workshop open to all community members with an interest in technical, operational, and security topics.

The <u>ccNSO Members Meeting</u> consists of 3 sessions and starts on Tuesday, 23 June with a session focusing on governance models for ccTLD Managers. The programme continues the next day, - Wednesday, 24 June - with presentations and discussions on "DNS in times of COVID-19: the ccTLD experience". The final session of the ccNSO Members meetings will be held on Thursday, 25 June when the ccNSO members and broader ccTLD community will be able to participate in a Q&A session with the ccNSO appointed ICANN Board members and others.

The <u>ccNSO Council</u> will have its formal meeting on Wednesday, 24 June 2020, which will be followed by a meeting by the Internet Governance Liaison Committee (<u>IGLC</u>). The Strategic and Operational Planning Committee (<u>SOPC</u>) will meet on Thursday, 25 June as well.

ccPDP3 Initial Proposals for Process to Retire ccTLDs

The ccNSO Policy Development Process 3 (ccPDP3) working group, tasked with developing and proposing policy for the retirement of country code Top-Level Domains, is seeking input and feed-back from the broader community on its proposed process to retire ccTLDs, when the country code is removed from list of country codes in the ISO 3166 standard.

After closure of the Public Comment period, the working group will review the comments received and take into account in developing a final set of policy recommendations.

Stay informed about ccPDP4

This fourth-ever ccNSO Policy Development Process aims to develop policy recommendations for the ICANN Board. In time, the results of this ccPDP will replace the IDN ccTLD Fast Track Process, which currently guides the selection process of IDN ccTLD strings.

During its meeting on 21 May, the ccNSO Council adopted the <u>Issue Report</u> on Internationalized Domain Name (IDN) country code top-level domain strings. With the adoption of this report, the fourth policy development process (ccPDP) for the ccNSO is initiated.

Mid-July 2020, the ccNSO Secretariat will send out a call for volunteers and will invite stakeholders as listed in the group's charter, to join the Working Group. Prior to this call for volunteers, the secretariat will organise a webinar to inform the community about the topics to be addressed and the working methods of the ccPDP4 WG.

Recent ccNSO Council discussions and decisions

The ccNSO Council met on Thursday, 21 May 2020. Consult the agenda and relevant

Virtual Council Workshop

On 3 June, the Council will hold its first Virtual Workshop, focusing on its Work Plan and the ccNSO priorities. This is a closed meeting.

Adoption revised ccNSO Guideline

The ccNSO Council adopted a revised version

of the Guideline: ccNSO Nomination Process Board Seat 11 and 12. Consult the most recent version of the ccNSO Guidelines **here**.

• Board Seat 12 nomination process.

The <u>timeline</u> has been adopted and the Nomination Process Manager has been appointed. The Nomination Process will start as early as 9 June 2020 to ensure that the background check procedure is completed prior to the ICANN69 Q&A session with the ICANN Board nominees. Adoption revised ToR IGLC

The Internet Governance Liaison Committee reviewed its Terms of Reference, and suggested some changes. Specifically it has introduced a mechanism for the <u>IGLC</u> to select the chair of the committee, aligning it with the regular mechanism that the chair is appointed by the Council after being nominated by the group.

Customer Standing Committee (CSC)

The ccNSO Council adopted the timeline as proposed for the selection of a ccNSO appointed member on the CSC, and requested the Secretariat to launch the call for volunteers starting on 2 June and closing on 16 June, in accordance with the mechanism in the Guideline: ccNSO Actions respecting the Customer Standing Committee. The ccNSO Council also confirms the appointment of the CSC selection committee. The mandate of this Council committee will be to consult with the RySG and GNSO Council and approve the full slate of membership. \
