

# ccNSO Newsletter | October 2019



The ICANN66 annual general meeting runs from 2 to 7 November 2019 in Montréal, Canada. The high-level ccNSO schedule for ICANN66 is available <a href="https://example.com/here/here/">here</a>.

The ccNSO program begins on Saturday, 2 November, with a meeting of the Internet Governance Liaison Committee (IGLC) and a three-hour meeting of the ccNSO Retirement of Country Code Top-Level Domains (ccTLD) Policy

Development Process (PDP) Working Group. On Sunday, 3 November, the ccNSO Council will hold a three-hour workshop, followed by a preparatory meeting where the ccNSO will plan for their joint meetings with the ICANN Board of Directors, the At-Large Advisory Committee (ALAC), and the Generic Names Supporting Organization (GNSO) Council. The Strategic and Operational Planning Committee (SOPC) and the Top-Level Domain Operations (TLD-OPS) Standing Committee will also hold meetings on Sunday. Tech Day, a workshop open to all community members with an interest in technical, operational, or security topics, is scheduled for Monday, 4 November. Tuesday, 5 November, and Wednesday, 6 November, are dedicated to the ccNSO Members Meeting, where the ccTLD community and others with an interest in ccTLD-related matters will discuss and receive updates on topics relevant to ccTLD managers. The ccNSO program ends on Thursday, 7 November, with a meeting by the Meetings Program Committee (MPC).

# Empowered Community Administration (ECA) Update

The **Empowered Community** is the mechanism through s Supporting w h i c h ICANN' (SOs) and Advisory Organizations Committees (ACs) can organize under enforce California law to legally community powers. The community powers and rules that govern the Empowered Community are defined in t h e ICANN Articles **Incorporation** and **Bylaws**.

The Empowered Community
Administration is the administrative body through which the Empowered Community acts. Each of the Decisional Participants of the Empowered Community designates one representative to the Empowered Community Administration.

## **Universal Acceptance Steering Group**

Universal Acceptance is the concept that all domain names should be treated equally. Domain names and e-mail addresses should be accepted, stored, processed and displayed in a consistent and effective

manner.

The UASG is the Universal Acceptance Steering Group. It was founded in February 2015 and tasked with undertaking activities that will effectively promote the Universal Acceptance of all valid domain names and email addresses. The group is made up of representatives from more than 120 companies, governments and community groups. ### IDN ccTLD Policy Update

On Thursday, 7 November, the ccNSO will hold a session to inform on and to discuss the next steps regarding the IDN ccTLD Policy Update, including

the preliminary timeline for the fourth ccNSO Policy Development Process. All interested are welcome and encouraged to attend. Join us on Thursday, 7 November | 10:30-12:00

### Background

The ccNSO Council requested the ICANN Board agree to end the second ccNSO Policy Development Process (ccNSO PDP2) on the selection of IDN ccTLD strings and inclusion of IDN ccTLDs in the ccNSO. Read the letter <a href="here">here</a>. The ccNSO Council also requested the ICANN Board that no further steps are taken to change the current IDN ccTLD Fast Track Process. In the absence of a formal policy, the current process enables countries and territories to request strings for IDN ccTLDs. It is the ccNSO Council's firm belief that, until a ccNSO policy replaces the IDN ccTLD Fast Track Process, the current process should remain in place.

The ccNSO Council intends to launch the fourth ccNSO PDP to build the work of the second ccNSO PDP2, and the experience of the IDN ccTLD Fast Track Process. The fourth ccNSO PDP will address issues identified by the ccNSO IDN PDP2 Preliminary Review Team (PRT), which includes outlining the differences between the similarity review and IDN Variant TLD Implementation and also streamlining the selection process of IDN (cc)TLD strings. The ccNSO Council is also in the process of preparing a request for changes to Article 10 of the ICANN Bylaws. The changes cover two aspects: an updated definition of ccNSO membership, and enabling IDN ccTLDs to become members of the ccNSO. In Montreal, the Council will consult the ccTLD Managers on the changes necessary to include IDN ccTLDs in the ccNSO.

## Candidates ICANN Board Seat 11

On Wednesday, 2 October 2019, 23.59 UTC, the recent call for nominations for the position of ICANN Board seat 11 was closed. In accordance with the applicable rules, the following candidates were nominated, seconded and have accepted their nomination:

## Candidates ccNSO Council

In accordance with the approved timeline, the nomination period for the ccNSO Council closed on Tuesday, 15 October 2019, 23:59 UTC. In accordance with the applicable rules, the following candidates were nominated, seconded and have accepted their nomination for the ccNSO council election:

• Africa: Souleymane Oumtanaga

• Asia-Pacific: Atsushi Endo, Ai-Chin Lu

• Europe: Giovanni Seppia

• Latin America – Caribbean: Alejandra Reynoso

• North America: Stephen Deerhake

Next steps: Africa, Europe, Latin America/Caribbean, North America

As only one candidate was nominated and seconded within the nomination period for the African, European, Latin American-Caribbean and North American regions, no elections need to be held in those regions. Since at the close of nominations there are no more valid candidates in the aforementioned geographic regions than there are seats on the ccNSO Council available for those regions, the nominated candidates shall be selected to serve on the ccNSO Council.

Next steps: Asia-Pacific

For the Asia-Pacific region, in accordance with the applicable rules, two candidates were nominated, seconded and have accepted their nomination. Consequently, an election will be held - according to the timeline previously agreed upon by the ccNSO Council - among the ccNSO members from the Asia-Pacific region. Voting starts on Tuesday, 19 November 2019 (00:01 UTC) and closes on Tuesday, 3 December 2019 (23:59 UTC)
