The term of the ccNSO Nominated Director fulfilling ICANN Board Seat 11 (Chris Disspain) will expire at the ICANN69 Annual General Meeting 2020 in Hamburg.

The ccNSO Council will open a call for nominations to fill ICANN Board Seat number 11 starting Wednesday, 11 September 2019 (00:01 UTC) and closing Wednesday, 2 October 2019 (23:59 UTC).

### Happy birthday .pr!



Pablo Rodriguez is the Executive VP of NIC.PR and ccNSO Council member. We recently asked Pablo about DNS Week and 30 years of .pr.

Pablo: "Gauss Research Laboratory, Inc. is celebrating this week 30 years of existence as operator for the .pr top level domain name. Three decades which have been characterized by constant challenges and learning experiences. Much has been achieved during this time, but perhaps more important

than any other, we feel pride to have been able to keep up with the times and implement changes that allow us to run a strong registry which plays a significant part of our local Internet community."

In collaboration with LACTLD, the .pr operator has developed a week-long full of events as part of its 30th anniversary. DNS Week (<a href="www.dnsweek.pr">www.dnsweek.pr</a>) is a four-day week of events organized by LACTLD and Puerto Rico Top Level Domain that will take place in San Juan, Puerto Rico, on August 20th to 23rd, 2019. Each event will address different topics related to the DNS and the operation and management of the ccTLDs, with a particular focus on the Caribbean region.

## ccNSO volunteer in the spotlight



#### Meet Annebeth Lange

Annebeth Lange, a lawyer of profession, has been involved in the work of ICANN and the ccNSO for quite some years, both from the government and the ccTLD side. She was recently appointed by the ccNSO as member to the 2020 Nominating Committee (NomCom). The ccNSO Secretariat asked her about her motivation to contribute to the work

of the ccNSO.

#### Question: Could you tell us a bit more on your background?

Annebeth: "In a previous role at the Norwegian government, I represented Norway in ITU meetings, following the WSIS process and other meetings under the UN umbrella. Moreover, I was the .no GAC representative for 7 years. Since I started working for the Norwegian ccTLD in 2007, I have been active in the ccNSO and in the ICANN community, especially with the new gTLD program working to find solutions for geographical names as TLDs. Through this work, and since 2012 acting as co-chair first in the Study Group, then the Cross Community WG and now in the Subsequent Procedures PDP, Work Track 5, I have expanded my experience working closely also with ALAC and GNSO."

## Question: What is your motivation for contributing to the work of ICANN and the ccNSO in particular?

Annebeth: "I believe in ICANN and the future of internet. ICANN has been an important part of my life since 2000. It has always been and still is of vital importance for me that the mission of ICANN, the multistakeholder model and the work accomplished by the organization continue. The task of finding the right persons for the leadership positions in ICANN is, in my view, is vital for continued success. With my long and varied experience of participation at different levels in the ICANN community and in the internet community as a whole, I hope to be in a position to contribute to that."

## Question: You were recently appointed by the ccNSO to the 2020 NomCom. What will you bring to this team?

Annebeth: "I like to think that I am considered a person of neutrality, integrity and objectivity that takes all views into consideration when being part of decision-making, and at the same time taking care of the interests of ccNSO. I have a wide net of contacts both in Norway and internationally and want to use my experience to contribute to the success of ICANN also in the future."

#### About the CSC

The CSC has been established to ensure the satisfactory performance of the Internet Assigned Numbers Authority (IANA) naming function. The CSC monitors PTI's performance of the IANA naming function by analyzing performance reports on a monthly basis and publishing its findings. It is authorized to undertake remedial action to address poor performance, and if performance issues are not remedied, the CSC is authorized to escalate the performance issues to the ccNSO and GNSO for consideration. Additionally, the CSC may recommend changes to the naming Service Level Expectations as well as enhancements to the provision of the IANA naming services.
