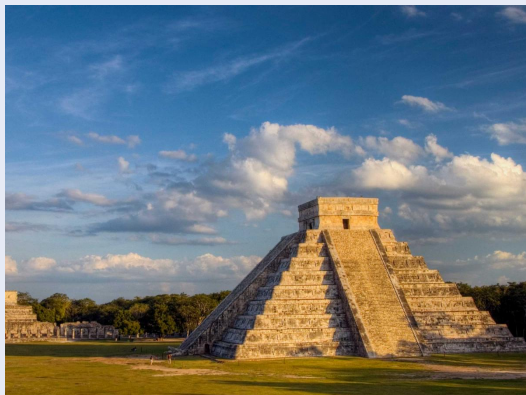

The ccNSO will host a community webinar, targeted at newcomers from the ccTLD community and those who want to learn more about the work of the ccNSO.

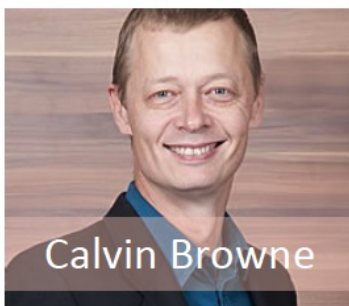

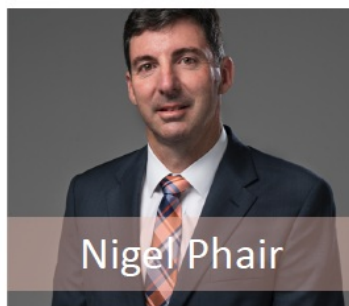

The ccNSO seeks volunteers (members and chair) for the second Working Group of the third ccNSO Policy Development Process (ccPDP3). This group will be tasked to develop the Review Mechanism pertaining to decisions regarding the delegation, transfer, revocation and retirement of ccTLDs.

The call for volunteers will close **Friday, 7 February 2020 (23:59 UTC)**.

About ccPDP3

This third-ever ccNSO Policy Development Process aims to develop policy recommendations for the ICANN Board, which will include a review mechanism pertaining to decision on the delegation, transfer, revocation, and retirement of ccTLDs.

In March 2017, the Council decided at the time to split the work in 2 phases:

- Phase 1: is about to conclude its work. This group focused on the retirement of the delegated Top Level Domains associated with alpha-2 codes assigned to countries and territories listed in the ISO 3166-1 standard. Read more [here](#).
- Phase 2: focus lies on the review mechanisms. The Phase 2 work will begin after the ccNSO Council approves the roster of volunteers.
