# ICANN Board adopted the ccNSO proposed policy on retirement of ccTLDs

The ICANN Board adopted the ccNSO proposed policy on the retirement of ccTLDs at its regular meeting, held on 22 September 2022 at ICANN75. This is an important milestone for the ccNSO and its third Policy Development Process (ccPDP3). The policy recommendations relate to the retirement of the delegated Top Level Domains associated with the country codes assigned to countries and territories listed in the ISO 3166-1 within the framework of the ccNSO Policy Development Process, as described in the ICANN Bylaws.

In July 2021, the ccNSO membership expressed via a <u>vote</u> its support regarding the ccNSO Council's recommendation to adopt the proposed policy on the retirement of ccTLDs.

#### ccPDP3-RET: Frequently Asked Questions & Answers

#### What is the policy about?

- 1. The trigger event for a ccTLD retirement process. The retirement process starts with the removal of a country code from the ISO3166-1 list of country names. For exceptionally reserved domain names, the trigger event is the fact that the ISO Maintenance Agency makes changes to the reserved 2-letter codes. For IDN ccTLDs, the trigger event will be identified under the ccNSO policy on the (de)selection of IDN ccTLD strings (ccPDP4). Note 1: the trigger is the removal of a country code, not the country code Top Level Domain. Note 2: RFC1591: IANA (the IANA Functions Operator) is not in the business of determining what is and what is not a country. ISO has a process to determine this.
- Impact of the trigger event on the Root Zone Database. Once a country code is removed from the ISO3166-1 list, the ccTLD MUST be removed from the DNS rootzone database. The rationale for this is that the link between the ISO3166-list and the list of ccTLDs should be maintained. Also, the ISO Maintenance Agency should be able to assign a 2-letter code to a new Territory.
- 3. **ccTLD retirement process.** Once there is a trigger event, the IANA Functions Operator sends a notice of retirement to the ccTLD Manager, with an invitation to discuss a retirement plan. The removal of the ccTLD from the root zone is foreseen to happen 5 years after the retirement notice. The ccTLD manager together with PTI can potentially agree to extend this deadline, with an additional 5 years.

#### Does this policy apply to all ccTLDs?

The policy is directed at ICANN, and is within scope of the ccNSO policy development

process, as stated in Annex C of the ICANN Bylaws.

#### ccPDP3 Part 2: Review Mechanism

The goal of the ccPDP3-Review Mechanism Working Group (ccPDP3-RM WG) is to report on and recommend a policy for a review mechanism with respect to decisions pertaining to the delegation, transfer, revocation and retirement of the delegated Top Level Domains associated with the country codes assigned to countries and territories listed in the ISO 3166-1 and within the framework of the ccNSO Policy Development Process. The group expects to finalise its initial report leading up to ICANN76.

recommendations, at sections 4 and 5 of the Initial Report. Following a call for volunteers, a small team (Irina Danelia, .ru and Molehe Wesi, .za), proposed a draft ccNSO submission in response to a request for comments on the Second CSC Effectiveness Review Initial Report. The ccNSO Council reviewed the draft submission, and now tasks the small team to seek comments and support by the ccTLD community.

The CSC ensures the satisfactory performance of the Internet Assigned Numbers Authority (IANA) naming function. The CSC is responsible for monitoring Public Technical Identifier's (PTI) performance of the IANA naming function against the service level expectations in the IANA Naming Function Contract. The CSC analyzes performance reports provided by PTI and publishes its findings. The CSC is authorized to undertake remedial action to address poor performance of the IANA naming function, and if performance issues are not remedied, may escalate the issues to the ccNSO and GNSO.
