I. EXECUTIVE SUMMARY

It took nearly two years of planning and countless meetings and the cast of hundreds of volunteers who were involved in putting this event together deserve a well-earned vote of thanks from the At-Large Community for its success. And, this was made a reality through the support given for the project and our vision for the future of At-Large by the ICANN Board and ICANN Org.

ATLAS III was the start of our search for future thought leaders and agents of innovation and change within At-Large in the key areas of policy and outreach and engagement. We wanted to encourage more meaningful engagement and participation by more of our At-Large community, so that we can be all become more effective contributors to ICANN's vision to ***be a champion of the single, open and globally interoperable Internet by being the independent, trusted, multistakeholder steward of the Internet's unique identifiers and by providing an open and collaborative environment where diverse stakeholders come together in the global public interest.***

In Montreal, ATLAS enabled our participants to experience the process of policy discussion and the policy development process within At-Large as well as the wider context of ICANN. They could then understand what the process entailed and what we mean by active participation and engagement. Each potential applicant had to undertake a series of ICANN Learn topics before they could even apply, not only to assess their interest and capacity for studying so that they could participate meaningfully in the policy work of At-Large, but more importantly, to gauge the level of commitment each applicant was prepared to give, to put themselves forward as potential At-Large Ambassadors. In At-Large, we need informed and active participation in our policy and outreach engagement activities. The reality of it all will be in their commitment when they start receiving a regular flow of emails and find they have to participate in long hours of meetings at unsociable hours, all in a virtual environment with people they may never get to meet, and with no assurance that travel to an actual ICANN meeting will ever eventuate. Our metric is - How many of the sixty participants we selected will we retain over the next five years??

We have to accept the inevitable. Many of our volunteers do not work in the domain name industry or even own a website. Many simply have an interest in learning more about how the Internet works and the importance of domain names and IP addresses within this network of networks. Many of our At-Large community may not come to ICANN initially with any real knowledge of the domain name system, but they believe in ICANN's multistakeholder model and have an interest in being among its diverse stakeholders who contribute to the formulation of policies that will maintain an internet that is open and trusted and has the public interest at its heart. The role of At-Large to harness this interest and to build a larger, stronger and well-informed community of active At-Large participants in ICANN's policy and outreach programs. We need to grow and build our At-Large Ambassador network within our global communities to raise awareness and build greater understanding among other Internet end-users about why they should help ICANN to achieve its mission.

Following Montreal, post-ATLAS activities have been developed to help us to achieve our goals for the future. It will begin with an analysis of the feedback from our new ATLAS Ambassadors. Recommendations from their feedback will be incorporated into our four proposed areas of continuous improvement within At-Large, our RALOs and out into the ALSes. These improvement areas are Policy Involvement, Capacity Building, Outreach and Engagement, and Communication – all aimed at enhancing our quality of participation in policy and outreach. An important outcome will be Sustainability Plan for Enhanced Participation by all our members. Other [Post-ATLAS activities](#) are found in the four key development areas of our At-Large 2020 Workplan (pp23-26). We have requested information about the actual cost of the event, so that we can make a further request to use any residual funds to help to support the implementation of some of our Post-ATLAS activities.

II. BACKGROUND

The development of the ATLAS programme arose out of our own internal review as to the effectiveness of our current use of our individual At-Large members to meet our policy and outreach engagement objectives and spreading appropriate outreach and policy messages out into their communities. While there is a long-standing goal to build our ALS numbers so that there is at least one ALS in each country, our principal goal is to make those who join up to be ACTIVE in our work. But we need to build capacity and understanding of the work we do in ICANN. This will require a lot of work and resources in order to help especially new members to gain a better understanding and appreciation of what occurs during ICANN's multistakeholder discussions and the diverse views that must coalesce in order to gain a consensus. To help with their enhancing understanding, we began 2019 in Kobe with the introduction of more policy sessions into our ICANN meetings and to bring other stakeholder groups into these discussions, to introduce At-Large not only to the diversity of perspectives but also to look at any common ground. We have also asked RALO leaders to cooperate by giving more focus to policy in their monthly RALO meetings and capacity building activities. In this way, potential applicants might realise the importance of having the appropriate knowledge and feel more comfortable with important issues they may come across at an ICANN meeting. It also highlighted for us that developing appropriate resources for ourselves and with ICANN Learn might help build and strengthen the development of new knowledge among those who want to be engaged and to participate. This is an important focus for moving At-Large forward and so it became our vision for ATLAS III - developing thought leaders and change agents who can enhance the contribution that At-Large can make in the ICANN of the future.

III. INTRODUCTION

1. FINALISING ATLAS II

Before we could officially undertake our ATLAS III event in Montreal, we first of all had to sign off on the final two advice items to the Board from the ATLAS II Final Declaration. The Board declared the following advice items as completed on 19 September 2019, although it must be noted that within ICANN, these advice items identified as concerns in 2014, still remain important issues in ICANN today. Brian Cute's project is working on Issue 1 and the Information Transparency Project will eventually get around to improving our wiki experience when other priorities are dealt with:

1. Future of Multi-Stakeholder Models (Recommendation 7): "A periodic review of ICANN's MSM should be performed to ensure that the processes and the composition of ICANN's constituent parts adequately address the relevant decision-making requirements in the Corporation."

2. Future of Multi-Stakeholder Models (Recommendation 37): "Additional logistical support from ICANN is needed to improve the At-Large wiki."

2. ESTABLISHING AN ORGANISING COMMITTEE

Discussions about what ATLAS III might entail were initiated at the Abu Dhabi meeting in October 2017 after we had been informed by ICANN Finance that the ATLAS would not be at the Kobe meeting in March 2019 as we had originally proposed, but would be delayed until the next financial year - to the

Montreal meeting in November 2019. In December 2017, a small group of former ATLAS organisers, started brainstorming about what our next ATLAS might involve and what metrics might be used to choose our travellers, noting the difficulties of assessing participation.

On 10 September 2018, we received a letter from the CEO and President, Goran Marby that the ICANN Board had authorised ICANN Org to contract for a meeting space for ATLAS III at the meeting in Montreal. We were then given a deadline of two weeks to identify how much space we needed, without the benefit of knowing what we were going to do or for how many people? This initiated a frenzy of meetings and discussions among a hastily constituted Organising Committee including Maureen Hilyard, Alan Greenberg, Olivier Crepin Leblond and Eduardo Diaz. Heidi Ulrich and Gisella Gruber as staff support and Chery Langdon-Orr who was seconded as a technical advisor. We made an urgent decision so that the Montreal Meeting Committee could finalise their own ICANN arrangements and from then on, we were able to finally start our own planning for ATLAS III.

IV. STARTING WORK ON ATLAS III

1. **THE ORGANISING COMMITTEE** – A small group (Alan, Maureen, Olivier, Eduardo and Cheryl) and At-Large staff first met on 14 Dec 2017 to start brainstorming possible ideas for ATLAS III that would help us establish a “journey”, based on earlier informal discussions at the Abu Dhabi meeting (ICANN60, Nov 2017). Our initial intent was to study metrics data from ATLAS II based on our internal tracking systems, to gauge any improvement in levels of ALS member participation in At-Large and ICANN activities since ATLAS II. ([Agenda](#)). The results that were available were not indicative of any real improvement in participation. This activated a specific improvement goal.
2. **SETTING UP FOR ATLAS III** – For most of 2018, active participants within At-Large were engaged in work activities associated with the eight (8) activities detailed in the At-Large Review Implementation Plan. An interim report was due in mid-December 2018. At the same time during this period, staff and the Organisation Committee began setting up processes and online workspaces in preparation for greater involvement by the At-Large Community. This involved the establishment of the [ATLAS III Summit Home Page](#) (p23) the development of an introductory overview about ATLAS and its purpose and goals (p23), as well as other relevant pages for the community wiki to cater for the Leadership Selection/Delegates and Program committees.

V. SELECTING THE ATLAS PARTICIPANTS

1. **CALL FOR AT-LARGE VOLUNTEERS** - Following a call for volunteers to participate in the two ATLAS III committees (Leadership Selection/Delegates Team and the Program Committee), a final list of [Delegates](#) and [Program](#) volunteers were formed by 4 December 2018. The Delegates team were to develop the criteria for selection while the Program committee were tasked with what the program would look like to achieve the objectives of our ATLAS event.

2. SURVEY OF ATLAS DELEGATES VOLUNTEERS

- a. At-Large volunteers in the Delegates group participated in a survey that looked at the skills and attributes of a leader, with specific attention to leaders within At-Large.
- b. A webinar was then presented to the combined Delegates and Program teams to deliver the analysis of the survey data and from the results, to build a set of criteria related to At-Large leadership from which the Delegates committee could create the final set of criteria and performance indicators for the selection process.
- c. The goal and objectives for the work of the Delegates group were reinforced.

GOAL

•To build strong leadership skills within At-Large that will develop competent, visionary and policy-focused leaders who will not only advocate for the rights and interests of Internet end-users within ICANN, but also appropriately represent the interests of ICANN within their local and global outreach and engagement.

OBJECTIVES

- Develop a set of demonstrable criteria to select 60 active At-Large invitees to ATLASIII
- Support the Programming Team’s preparatory program for prospective applicants

3. SELECTION OF THE PARTICIPANTS

- a. **The Delegates team** was then divided into 4 groups of about 7-8 people (this included a Spanish-speaking group of 7 members) to select their criteria and to set their performance indicators. These were then discussed by the full group and a small group consisting of the 4 group leaders, created a final list of desired leadership skills and attributes, and performance indicators. This team also decided that there were three important criteria that any applicants had to align with in order to even proceed to the application process
 - i. They were a member of an ALS or a registered unaffiliated member
 - ii. They had completed the 5 study (ICANN Learn or webinar) activities that the Program Team were developing
 - iii. They had attended at least one RALO, At-Large or ALAC meeting
- b. **Selection Matrix** - a matrix was designed by Justine Chew (APRALO) to automate much of the selection process based on the results of the application form. The staff was given some training in the use of the matrix. A separate set of questions would provide the final assessments which would be done by a special Applicant Selection Committee.
- c. **Equity issue** - During the Kobe meeting in February, there was some considerable discussion about the limitation of 60 candidates imposed by the Board. There was concern raised by some that some RALOs would be more advantaged than others. The ALAC Leadership Team agreed that there should be at least 10 attendees from each RALO from among all those that applied. This recommendation was accepted by the At-Large group. We were later to find that because there were minimal applicants from EURALO and NARALO, there were 19 applicants who were selected from AFRALO and yet 7 were unable to attend due to visa issues.

- d. **Applicant Selection Committee** – While the mandatory application criteria and the automated application selection matrix dealt easily with much of the application data, there was a section relating to performance indicators that required some human assessment. The requirements of each RALO’s candidate for this role were:
- i. **Representative of a Regional At-Large Organisation (RALO)**
 - ii. **Experience as a leader** in At-Large or other ICANN section
 - iii. **Had an awareness about ATLAS and its objectives**

The RALOs selected: Fatimata Seye Sylla (AF), Holly Raiche (AP) Yrjo Lansipuro (EU) Humberto Carrasco (LAC) and John Laprise (NA) who conscientiously assigned scores to the individual responses from the application forms that had been separated by staff to only include those who had fulfilled the pre-learning and membership expectations.

e. **THE ANNOUNCEMENT:**

A final list was successfully selected and agreed upon at the Marrakech meeting by the panel but there was a snag to the publication of the list of successful candidates on the designated day. Because we had neglected to ask applicants for their permission to display their names and RALOs if they were successful (due to GDPR requirements), Legal would not allow the list to be published, even on our wiki space which requires an entry login. This created a lot of confusion among the At-Large members who wanted to know the results of the selection process, so that At-Large staff were required to notify all the 60 successful candidates individually. It was at least a week later before a final list was able to be published. There is now a requirement for members to give their permission to have their names published on our wiki space for working groups as well as situations such as this.

VI. DEVELOPING THE PROGRAM

The Program Committee divided their proposed activities up among three key subgroups

1. Capacity
2. Program
3. Outcomes

1. CAPACITY SUBGROUP

The capacity sub-group decided that in order to be assured that everyone who was intending to participate in the ATLAS event was on the same level of understanding about how ICANN works and some key areas of policy, that they would insist that all applicants must undertake a study course that could establish at least some common understandings among those who were selected to participate in the event. These were to be offered either by webinar or the ICANN Learn courses. Webinars were offered in Spanish and French and English, but the ICANN Learn programs were predominantly in English. The issue of translations is an area we would like to address as part of our Communication Strategy 2020.

The ICANN Learn courses selected for ATLAS III Pre-learning, included:

1. [Domain Names Demystified](#)
2. [Introduction to the Generic Names Supporting Organization \(GNSO\)](#)
3. [Onboarding: Country Code Names Supporting Organization \(ccNSO\)](#)
4. [Onboarding: Governmental Advisory Committee \(GAC\)](#)
5. [Cybersecurity Basics](#)

The webinars involved the much appreciated participation of members from our partner organisations in ICANN and included the following topics:

1. Domain Names (based on our selection of the ICANN Learn “Domain Names Demystified”)
2. GNSO (based on our selection of “Introduction to the GNSO”)
3. ccNSO (based on our selection of Onboarding: ccNSO”)
4. GAC (based on our selection of Onboarding: Governmental Advisory Committee (GAC)
5. Cybersecurity (based on our selection of Cybersecurity Basics)

Participants interested in applying for ATLAS III had to complete at least the Webinar or its associated ICANN Learn topic in each of the 5 areas. ICANN Learn had its own monitoring system and could pass on the completion results of each participant. Webinar attendance was recorded by staff during the first ten minutes of the session. Anyone joining after this without providing an explanation was counted as absent. We were insistent that timeliness was a serious component of consideration of their future applications. Their complying with these expectations allowed them to be added to the matrix and sent the [application form](#) for completion of the second phase of the application process – the assessment of their active participation in At-Large or ICANN activities by the ATLAS III Selection Panel.

2. PROGRAM SUBGROUP

The Program Subgroup were fortunate to employ the skills of David Kolb of Incite Learning to work with them on developing a suitable program that could introduce Leadership alongside a skills-based program to introduce the ATLAS participants to policy issues. This was done by an alternate program of plenaries and practical breakout sessions. Plenaries involved some formal presentation that focused mainly on leadership.

The essential backgrounder to the ATLAS III Program was the introduction to GDPR and the EPDP based in an imaginary land where it was the task of discussion groups to unpack and evaluate the diverse opinions of the different “tribes” and to work towards achieving consensus about the matter under discussion. These discussions formed the context for the breakout sessions. The concept of consensus – the desired outcome of discussions in At-Large – was also discussed.

3. OUTCOMES SUBGROUP

This group became more active as the program developed and began creating a survey which would not only gather feedback on what the participants might have learned from the ATLAS program, but also how they might use their new learnings as they became more involved in policy discussions. For many of our new ICANN meeting attendees, this was at an introductory level. The purpose of the leadership and policy combined program was to develop thought leaders who might use this opportunity to build on what they had learned and become more active in participation that would help them to be better policy advocates and more effective Outreach and Policy Ambassadors in their regions for At-Large.

The [Post-ATLAS survey](#) is currently being undertaken by ATLAS participants and an analysis of the feedback will contribute to the development of other already identified tasks and activities that constitute our planned set of [POST-ATLAS activities](#).

1. ATLASIII WEBINARS – PREPARING FOR MONTREAL

- a) [Visa and Travel information](#): This webinar involved a presentation by Joseph de Jesus from Constituency travel to talk about travel and visa issues, and an opportunity for anyone to ask any questions of concern to them. At the time (October) visa issues were a concern, particularly from the African region although other countries were already experiencing difficulty trying to comply with the documentation needs expected of the Canadian authorities connected to their particular countries. By the time we got to Montreal, only 43 of the original 60 selected participants were able to attend in person in Montreal. 7 members withdrew for work-related reasons, while 10 were denied entry into Canada. There was a lot of discussion before their arrival that ICANN needs to consider visa issues for some countries that often experience difficulty. There did seem to be some inconsistency in the way that visas appeared to have been issued. If At-Large is to be fully participative, then ICANN must try to ensure that those who are entitled to come and have met the strict pre-conditions that we set for them to participate, should be given every opportunity to attend. It was suggested that the choice of venues for future ICANN meetings needs to be more carefully considered.

- b) [What to expect at ATLAS III?:](#) This webinar involved an explanation of the Case Study on which the break-out sessions were based; and introduction to the ICANN meeting schedule and sessions that travellers would be expected to attend; Key ATLAS III messages and how to spread the word about what we were trying to achieve from ATLAS III; and some information about registration, travel, and accommodation.

2. WELCOME TO MONTREAL



The first event of the ATLAS program was a brief Welcome by the ALAC Chair, establishing the purpose of the event and the outcomes we hoped to achieve in order to enhance the work of At-Large within the ICANN of the future.

The CEO and President, Goran Marby, then congratulated everyone who had been able to make it to Montreal, and for the effort that had been made by the staff and leadership of At-Large, but also by the travellers who had had to go through an arduous application process to be included into the event. He wished everyone an enjoyable meeting.

3. INTRODUCTION TO THE PROGRAM BY DAVID KOLB – THE KEY ATTRIBUTES OF LEADERSHIP.

The ATLAS program was introduced by a **panel of leaders** from across the five RALOs expressing their views about the characteristics and core attributes of leaders within At-Large. The panel included Jonathan Zuck (NA), Roberto Gaetano (EU) Fatimata Seye Sylla (AF), Justine Chew (AP) and Leon Sanchez (LAC).

Following this panel discussion and questions from the floor, David Kolb of Incite Learning continued with a plenary [presentation](#) that further explored leadership characteristics, attributes and skills. The topics he discussed included: Thought and Change Leadership, Effective Communication, Conflict and Influence, Intercultural Awareness, Coaching, Personal presence, Presentations, Time Management, Delegation and Meeting Facilitation.

The full ATLAS III program can be found on pp 17-19. Plenary sessions were interspersed with Break-out sessions which were related to the Expedited Policy Development Process (EPDP) on Temporary Specification for gTLD Registration Data under discussion. These training sessions gave individuals an opportunity to self-activate some of the leadership theory within the breakout activities. There were animated discussions and participants became very much involved in their role play activities, guided by mentors and coaches from among the ALAC and RALO leaders assigned to each of the groups.



This was the multistakeholder session where headphones were necessary as participants contributed a steady discussion in French, Spanish and English. Thank you to the Interpreters who did a great job all week.

4. ATLAS III COMMUNICATIONS STRATEGY AND AT-A-GLANCE MESSAGE POINTS

Throughout the build-up to ATLASIII, travellers were directed to the ATLAS Communications Strategy Wiki space and the message points that we wanted ATLAS Travellers to convey in their hallway and networking conversations. These messages were specifically targeting At-Large and ICANN Community members including ICANN Org. These messages applied to At-Large Leaders as well as ATLAS II Participants before, during and after ATLAS III.

ATLAS III is an assembly of future At-Large Ambassadors, focused on developing and nurturing potential thought leaders and change agents who will implement what has resulted from the At-Large Review Process, namely, more effective participation of At-Large members in the policy advice process.

Three Key Messages:

- ATLAS III is an assembly of future policy and outreach ambassadors.
- ATLAS III will provide participants with the skills required to effectively represent the best interests of end users within ICANN.
- ATLAS III Ambassadors will be our thought leaders and change agents within At-Large and ICANN.

5. PRIZEGIVING – CERTIFICATES AND AT-LARGE AMBASSADOR PINS

At the conclusion of the ATLAS event, each participant received a certificate and At-Large Ambassadors pin to commemorate the event, but only if they had attended all the plenaries and breakout sessions and were active participants in ATLAS assignments particularly the breakout sessions. Gifts were presented to those in attendance in recognition of their participation. Many thanks to the At-Large staff for their outstanding efforts to ensure that things went smoothly for the presenters and the participants. Thanks to Heidi, Gisella, Silvia, Evin, Yesim and Michelle.



6. PRE-ICANN66 POLICY REPORT TEXT (BY AT-LARGE STAFF):

The Third At-Large Summit (ATLAS III)

At the ICANN66 Annual General Meeting (AGM) the main focus of the At-Large community will be the third At-Large Summit (ATLAS III) which will take place, 4-7 November 2019. ATLAS III is the key event in the At-Large 5-year cycle and will help shape the activities of the At-Large community in the years ahead.

ATLAS III is an assembly of future policy and outreach ambassadors which will provide participants with the skills required to effectively represent the best interests of end users within ICANN.

Nearly 60 members were selected to take part in the third At-Large Summit (ATLAS III) that is taking place 4-7 November during ICANN66. The ATLAS III participants were required to complete a series of courses on issues of importance to ICANN and At-Large as well as complete an application before being selected by the ATLAS III Selection Committee.

The summit will consist of a series of plenary sessions and 7 break-out groups which will provide training and interactive, hands-on practice of key learning skills. A case study on the EPDP Phase 1 will serve as focus for the training. Current At-Large leaders will serve as coaches and facilitators of the break-out sessions. ATLAS III also will include networking events to facilitate the ability of participants to get to know At-Large members from around the globe as well as members of the ICANN community. All ATLAS III participants will be clearly recognizable with a purple ATLAS III ribbon on their name tag, so feel free to speak with them.

The final day will be reserved for a wrap up and discussing post-ATLAS III activities. Post-summit activities will include the establishment of an ATLAS III Ambassador program to assist in working on ensuring the increased engagement being thought leaders and change agents within At-Large and ICANN . This program will run in parallel with the At-Large Review Implementation Issue 2, focusing on increasing the engagement of ALSes and individuals.

7. POST-ICANN66 POLICY REPORT TEXT (BY AT-LARGE STAFF):

Third At-Large Summit (ATLAS III) Activities

The third At-Large Summit (ATLAS III) was an assembly of future policy and outreach ambassadors who will implement outcomes from the At-Large Review such as the participation of At-Large members in the ALAC policy advice process. The Summit consisted of a series of plenary sessions and six breakout groups which provided training and interactive, hands-on practice of key skills. A case study on Phase 1 of the Expedited Policy Development Process (EPDP) on the Temporary Specification for gTLD Registration Data served as the focus for the training. Current At-Large leaders served as coaches and facilitators of the breakout sessions. ATLAS III also included networking events for participants to get to know At-Large members from around the globe as well as other members of the ICANN community.

VIII. BOARD ACKNOWLEDGMENT OF ATLAS III

Whereas, the Third At-Large Summit (ATLAS III) was held during ICANN66 in Montreal, Canada between 4 November and 7 November 2019.

Whereas, ATLAS III built on both ATLAS II held at ICANN50 in London, United Kingdom in June 2014 as well as the first summit organized in March 2009 at ICANN34 in Mexico.

Whereas, the At-Large community continues the Summit's spirit of engagement and nurturing the abilities of future leaders of At-Large to become change agents within their Regional At-Large Organizations (RALOs) through a set of post-ATLAS III implementation activities.

Resolved (2019.11.07.17), the Board extends its congratulations on the successful Summit held during ICANN66 in Montreal.

Resolved (2019.11.07.18), the Board affirms the significance of the ATLAS III meeting and its outcomes as valuable input from the At-Large community of individual Internet users towards strengthening ICANN.

Resolved (2019.11.07.19), the Board expresses its great appreciation for the tremendous effort made by the At-Large community in delivering the Third At-Large Summit and the post-ATLAS III implementation activities.

Resolved (2019.11.07.20), the Board looks forward to following up with the ALAC on any inputs that are provided to the Board resulting from the Third At-Large Summit and post-ATLAS III implementation activities.

Rationale for Resolutions 2019.11.07.17 – 2019.11.07.20

The Third At-Large Summit (ATLAS III), which was made possible by the Board approving funds for the event, is an assembly of future At-Large Ambassadors, focused on developing and nurturing potential thought leaders and change agents who will implement what has resulted from the At-Large Review Process, namely, more effective participation of At-Large members in the policy advice process.

A Board Resolution acknowledging the significant effort, including over 12 months of planning that went into the development and implementation of ATLAS III, will have positive community impacts. The ATLAS III Organizing Committee, ATLAS III Program Working Group, ATLAS III Leadership Development Team, ATLAS III Selection Committee, ATLAS III participants, At-Large Leadership, and other members of the At-Large community would welcome Board acknowledgement and thanks for a successful ATLAS III.

The At-Large community will begin work on a number of Post-ATLAS III implementation activities immediately following the close of the Third At-Large Summit. The Post-ATLAS III implementation will take the place of a formal Declaration such as was submitted at the two previous At-Large Summits.

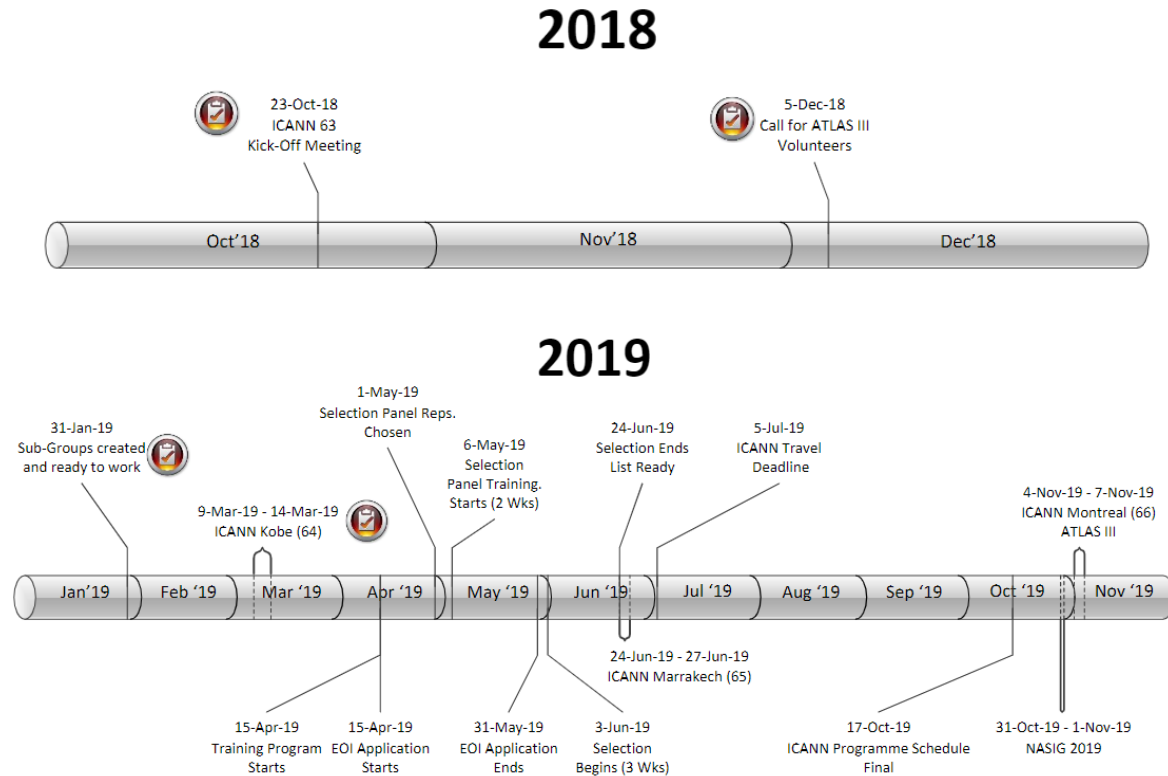

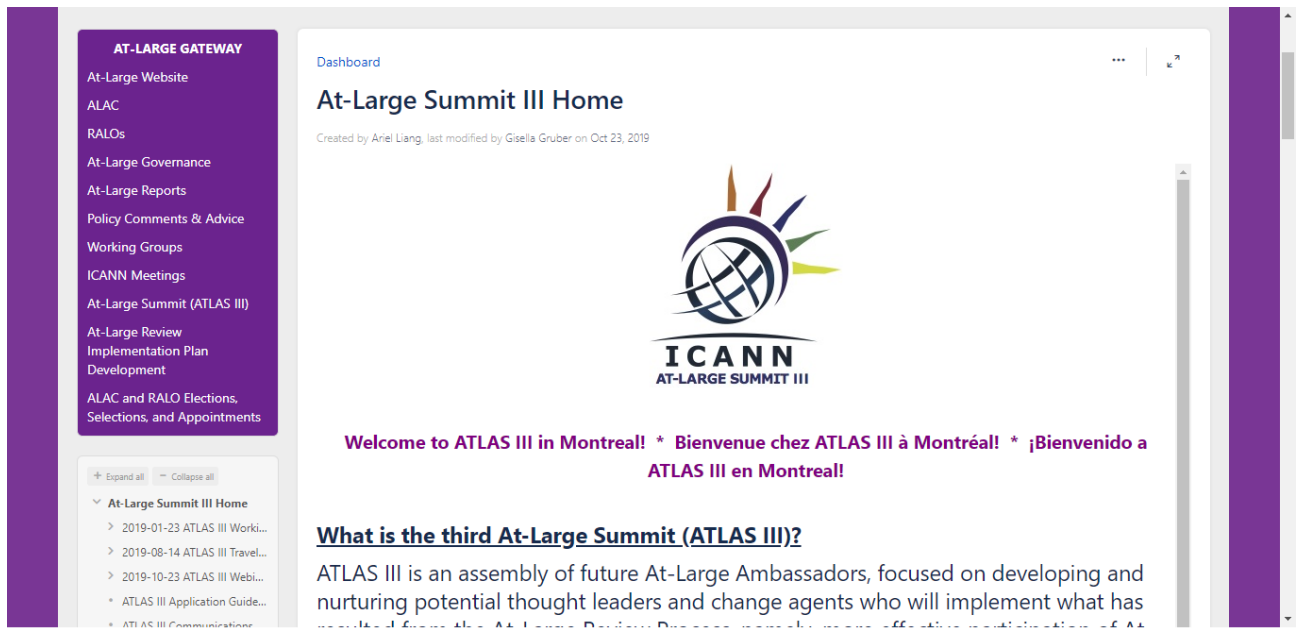
